

## Associated Students, SJSU, Board of Directors' Resolution 21/22-01

## **Kirpan Rights**

Whereas, The Associated Students (A.S) of San José State University (SJSU) is the official voice for over 33,000 students in the California State University (CSU); and

**Whereas,** It is the mission of Associated Students to support and represent the students of San José State University by continuing the organization's legacy of student advocacy and leadership; to enhance SJSU students' education through high quality programs and services; and to prepare students as they move towards a thoughtful and purposeful life after graduation<sup>1</sup>; and

**Whereas,** As of Fall 2020, San José State University is home to 11,346 Asian identified Spartans  $(34.4\%)^2$ ; and

Whereas, This Resolution document seeks to build upon prior Associated Students Resolutions related to the Asian, Pacific Islander, Desi, South/East Asian / American (APIDS/EA/A) community and to further amplify APIDS/EA/A Spartan voices<sup>3</sup>; and

Whereas, Many Sikh students at San José State University seek a sense of belonging within the institution and a policy to improve religious competence contributes to the sense of belonging they seek; and

**Whereas,** The First Amendment to the United States Constitution, Free Exercise Clause, "protects citizens' right to practice their religion" <sup>4,5</sup>; and

Whereas, University Policy S01-13 states SJSU is committed to, "maintaining a climate where individuals feel welcome" and "ensuring that federal and state laws pertaining to affirmative

action, non-discrimination, equal opportunity and prohibition of harassment are fully enforced"<sup>6</sup>; and

**Whereas,** One of the desired outcomes of SJSU's Transformation 2030 plan under Goal 3: Grow and Thrive is to "foster an inclusive environment and infrastructure where diverse populations can flourish" <sup>7</sup>; and

**Whereas,** The Office of Diversity, Equity, and Inclusion (ODEI) states, "San José State's mission of academic excellence as inseparable from [SJSU's] commitment to diversity, equity, and inclusion" demonstrating a commitment to social justice and a campus free from discrimination and free from systemic and cultural barriers to academic and professional success for all of its students, faculty, staff, and administrators<sup>8,9,10,11</sup>; and

Whereas, It is the responsibility of Associated Students to protect student rights including religious freedoms, while ensuring public safety; and

**Whereas**, Sikhi is the world's fifth largest religion in the world with 25 million Sikhs worldwide and over 500,000 Sikhs in the United States 12,13,14,15,16; and

Whereas, Part of the Sikh identity is founded on the idea of oneness and equity for all<sup>17</sup>; and

**Whereas,** That includes carrying five articles of faith: kesh, kanga, kara, kirpan, and kachera distinguishing someone who has formally committed to the values of the Sikh faith<sup>18,19</sup>; and

Whereas, Another practice Sikhs (both men, women and nonbinary individuals) observe is wearing the Dastaar which has continued for centuries and it remains as one of the most visible, distinctive features of Sikhi as a symbol of sovereignty; and

**Whereas,** The Kirpan, "obligates a Sikh to the ideals of generosity, compassion and service to humanity. It acts as a reminder to its bearer of a Sikh's solemn duty to protect the weak and promote justice for all" ; and

Whereas, It is Associated Students' goal to promote education and awareness of Sikhi and the practice of carrying a Kirpan when its possession is in accordance with an integral part of Sikhi and there is benign intent in carrying it; and

Whereas, A standalone, weapons exception policy creates broader public awareness of Sikhi, acknowledges the Sikh community, and encourages religious competence; and

**Resolved,** That a weapons exception policy be created to acknowledge those Sikhs that observe the practice of wearing a Kirpan to ensure a sense of safety and belonging at San José State University by the Office of the President<sup>21</sup>; and further be it

**Resolved,** That intentional and diverse religious training be compiled and procedurally incorporated for all University Police and Security Officers periodically and be complied with the appropriate subject matter experts<sup>22,23</sup>; and further be it

**Resolved,** That the training content includes information on how to recognize and interact with persons carrying a Kirpan, instruction on how arrests of Sikhs carrying a Kirpan have historically been treated and the alternatives to those arrests and detentions that have successfully been used, and define a Kirpan as a integral part of the practice of Sikhi<sup>24</sup>; and further be it

**Resolved,** The training also include a community panel to help engage, connect and foster relationships; and further be it

**Resolved,** That San José State University faculty, staff, administrators and students receive training content as well on the same subject matter; and further be it

**Resolved,** That all San José State University entities acknowledge the Sikh community by engaging Sikh student organizations to create a sense of belonging and safety; and further be it

**Resolved,** That San José State University maintain ongoing conversations with the Sikh community in order to create efforts and initiatives that aim to improve the experience for Sikh students on campus; and further be it

**Resolved,** Sikh history must be taught and included in ethnic studies courses at San José State University in order to "will help to solidify the progress that has been made for diversity and inclusion over the last decade"<sup>3,25</sup>; and


