- All fees are mandatory
- Bills will be sent to Sponsors
- Students pursuing their second bachelor's degree will be charged as a graduate student
- Non-resident students pay the amount above plus \$339 per unit
- If the invoice for the student's registration fees is still outstanding at sixty-one days, we will place a hold on the student's account. This will block services provided to the student (such as future registration access, transcripts, and graduation processing)
- We will not honor future authorizations from the agency until the invoice has been paid
- If the invoice is still outstanding at ninety-one days, we may transfer the charges from the Third Party Sponsor account to the student's account and pursue collection from the student, and if necessary, take disenrollment action. We regret taking this action, but we can no longer carry receivables beyond the current term
