For appointment at the Assistant Professor rank, potential for excellence in teaching, curriculum development and scholarship. For appointment at the advanced rank, must have broad teaching experience and significant scholarly and professional accomplishments. Evidence of successful work with ethnically and culturally diverse populations and communities. Applicants should have awareness of and sensitivity to the educational goals of a multicultural population as might have been gained in cross-cultural study, training, teaching and other comparable experience.

**Preferred:** The candidate should demonstrate ability to address the needs of ethnically and culturally diverse college students, experience in any of the areas of higher education student services, counseling foundation, organization change and consultation, human growth and development, student service management, college outreach, and an interest in developing grants, initiating and publishing research, and presenting at conferences in the area of counseling and higher education student services; evidence of ability to use learning technology in teaching.

**Responsibilities:** The candidate will teach graduate courses in Counselor Education; supervise students in practicum and fieldwork assignments, advise graduate students, participate in committee services; initiate research and development grants and other scholarly activities. Candidate must address the needs of a student population of great diversity – in age, cultural background, ethnicity, primary language and academic preparation – through course materials, teaching strategies, research and advisement.
