VISITING REGULATIONS FCI - FDC - FPC Dublin, California

- All adult visitors (16 years and older) are required to present acceptable means of picture identification, with signature, prior to being admitted into the institution for a visit. Acceptable forms of identification include, but are not limited to, a valid driver's license, valid state identification card, passport, or other official government-issued picture identification. Visitors without proper identification (photo identification) will not be permitted to visit.
- Visitors will not be permitted into the institution wearing any clothing which resembles inmate issued uniforms (i.e., khaki colored clothing), hats other than religious headgear, sweat suits/jogging suits, shorts, see-through blouses, halter tops, spandex, or any other type of provocative clothing.
- Visitors may bring a maximum of \$25.00 per adult. Inmates are prohibited from possessing any form of currency.
- 4. Tobacco products are permitted in the factory sealed packages only.
- Visitors are NOT allowed to bring in any type of weapon, ammunition, drugs, or narcotic. Cell phones, pagers, cameras and tape recorders are prohibited.
- Visitors will be required to secure articles (purses, backpacks, etc.) in their vehicles before being processed for visitation. All items are subject to search before entering the institution.
- Medication of an emergency nature, such as asthma inhalants or nitroglycerine, are allowed; however, all medications must be declared to the Front Entrance Officer.
- 8. Any individual believed to smell of alcohol, or who appears to be under the influence of alcohol or drugs, will be denied entry.
- Handshaking, embracing, and kissing by visitors is not permitted. Inappropriate behavior or contact may result in termination of the visit.
- 10. FCI Dublin reserves the right to refuse admittance to anyone who fails to comply with our policies. Violations of these guidelines can result in a suspension of the inmate's visiting privileges.
- 11. 18 U.S.C. §§ 1791 and 3571 provides a penalty of imprisonment for not more than twenty years, a fine of not more than \$250,000 or both, to a person who provides, or attempts to provide to an inmate, any prohibited object.



From Oakland International Airport (OAK) - Airport with best access

Take 880 South toward San Jose Take 238/580 South toward Stockton/Fresno Continue on 580 East

Heading East on Interstate 580

Exit Hopyard Rd. / Dougherty Rd. Go left over the freeway. Right on Dublin Blvd. (It will be the first road you come to.) Left on Camp Parks Blvd. into the entrance for Parks Reserve Base.

Heading West on Interstate 580

Exit Hacienda Rd. and turn right. Left on Dublin Blvd. (It will be the first road after the mall.) Right on Camp Parks Blvd. into the entrance for Parks Reserve Base.

Once on the base

You will need to stop at the gate and show your picture id before entering the base. You may be randomly chosen to have your vehicle searched or asked to present proof of insurance or vehicle registration.

Right on 4th Street. (Camp Parks Blvd. ends at 4th Street.) Left on Hutchins Road. (First road on left.) Right on 8th Street. (Hutchins Rd. ends at 8th Street.) FCI Dublin will be on the left. Park in the main parking lot. Go to the brown building across from the flag pole.

You will need to give the officer at the front desk a picture id and your license plate number. You will not be able to bring cell phones or pagers into the institution. Please leave these items in your car.

Driving on Base

The speed limit is 25 mph (slower if troops are present). Come to a complete stop at all stop signs.

From San Francisco International Airport (SFO)

Take 101 South towards San Jose
Take 92 East (San Mateo Bridge)
After the bridge, take 880 North
Take 238/580 South toward Stockton/Fresno
Continue on 580 East
Immediately after you pass the 680 interchange,
Exit Hopyard Rd. / Dougherty Rd.
Go left over the freeway.
Right on Dublin Blvd. (It will be the first road you come to.)
Left on Camp Parks Blvd. into the entrance for Parks Reserve Base.

SFO to San Francisco

Take 101 North towards San Francisco

San Francisco to Dublin

Take I-80 E over to the Bay Bridge East towards Oakland
After you get over the Bay Bridge
Follow the signs carefully for I-580 East to Oakland / Hayward-Stockton
Go 25 miles on 508 to Dublin
(Watch the signs carefully after about 10 miles, because you'll need to be in the right lanes as the freeway goes under itself and to the East)
