**Part-Time Lecturer in Punjabi**

**Brief Description of Duties:**

Teach courses in elementary and intermediate Punjabi and material related the culture, history, and arts of Punjabi-speaking societies. Deploy distance learning and web technology to deliver instruction and course materials, including audio-visual streaming. Collaborate with Punjabi activities coordinator to organize instructional and resource materials for the Punjabi Studies web site and activities involving students.

**Minimum Qualifications:\***

Required: Ph.D or MA in Punjabi or relevant field. Native or near native knowledge of Punjabi and fluent in English. Ability to teach Punjabi language elementary and intermediate courses at the university level; in-depth knowledge of the culture of the Punjab and the Diaspora. Demonstrated success in teaching at the university level. Solid knowledge and experience in technology-mediated instruction such as teaching through video conferencing and distance learning, on-line delivery, and use of audio-visual streaming. Applicants should have awareness of and sensitivity to the educational goals of a multicultural population as might have been gained in cross-cultural study, training, teaching and other comparable experience.
