This would be an unfair impact on students from Santa Clara county, who are the true "local" students in proximity to SJSU.</p> <p>Even though my own child living in San Francisco would benefit from this bump, I think it is unfair to Santa Clara county students, because SJSU is already an impacted CSU. There are already many local students in Santa Clara county who are turned away. Most of our transfer-bound students at De Anza College are also Santa Clara county, and even more specifically, San Jose residents. I have taught undergraduate Sociology courses for the past 15 years with the Foothill De Anza College district. The majority of our students apply for transfer to San Jose State University because it is the most economically accessible institution that will help them advance in their pursuit of higher education. I teach mostly first generation students of color who are also low income. The majority of my students would find the costs associated with relocating to another city to pursue an undergraduate degree cost-prohibitive and would most likely delay this pursuit indefinitely or permanently, to the detriment of the communities that make up Santa Clara county.</p> <p>Expanding the admissions area to the counties listed above with a GPA bump would disproportionately impact our most vulnerable students, for whom higher education is an absolute necessity for living in this valley and lifting themselves and their families out of poverty. I also question the wisdom of enacting such a policy change when the University is already impacted across various undergraduate areas of study, making it difficult as it is for students from Santa Clara county to transfer to San Jose State University.</p> <p>The Administration of San Jose State University needs to understand that expanding the admissions area would disproportionately impact, poor and low income students, Latinx students, students who are undocumented, students with disabilities, Filipinx and South East Asian students, and other underrepresented student communities whose families have sacrificed and struggled so much to support their children in their pursuit of higher education.</p> <p>As an educator in Santa Clara county, and on behalf of my students, please do not expand the Admissions area beyond what is already the case.</p>	<p>We appreciate your feedback and comments during this public hearing period as San José State University considers changes to its admissions policy.
