Course Description

Advanced skills in writing. Development of writing style and creation of organized, persuasive, and analytical prose. Generalized and specialized forms of writing.

Prerequisite: ENGL 001B (with a grade of C or better); Completion of core GE, satisfaction of Writing Skills Test and upper division standing; KIN 70 for major/minors only or instructor consent.

Note: Must be passed with C or better to satisfy the CSU Graduation Writing Assessment requirement.

Course Goals and Student Learning Objectives

Students shall write complete essays, articles, and other documents that demonstrate college-level proficiency. Students shall be able to:

1. produce discipline-specific written work that demonstrates upper-division proficiency in:
 - language use

- grammar
 - clarity of expression
2. explain, analyze, develop, and criticize ideas effectively, including ideas encountered in multiple readings and expressed in different forms of discourse
 3. organize and develop essays, articles, and other documents for both professional and general audiences
 4. organize and develop essays, articles, and other documents according to appropriate editorial and citation standards in American Psychological Association (APA) style
 5. locate, organize, and synthesize information effectively to accomplish a specific purpose and communicate that purpose in writing

Course Objectives

Upon successful completion of KIN 100W, the student will be able to:

- a. write with brevity and precision of expression.
- b. recognize and produce different styles and levels of writing.
- c. write in business letter format.
- d. prepare a resume and cover letter.
- e. locate and effectively use credible, academic resources.
- f. write a cohesive expository response with correct grammar, mechanics, clarity, and punctuation.
- g. write an abstract for a journal article.
- h. write a problem statement for both a quantitative and a qualitative research proposal.
- i. write a literature review article for a professional publication using APA format.

Assignments:

Specific requirements for each assignment will be provided in class and via PowerPoint slides. The descriptions below are general descriptions of the assignments. If there are variations in the requirements, the order of precedence is the directions provided in class, then the PowerPoint slides, then the descriptions below.

a. Topic Proposal (5% pts.)

You will be writing a literature review of a topic that is relevant to kinesiology. Give your proposal a title that describes your research topic. Your proposal should be 2-4 pages in length and address the following questions: 1) What is your research topic? *Describe at least three aspects of it.* 2) What is your personal relationship to this topic? *What drew you to this topic?* 3) What is the larger significance of your topic? *Who or what could benefit from your research?* 4) How will your topic include multicultural and/or diversity perspectives? 5) What is your proposed thesis statement?

Length: 2-4 pp.

b. Annotated References (5% pts.)

Submit an annotated bibliography for **21 scholarly sources** published within the past 10 years. At least 15 of the sources must be academic peer-reviewed articles, which are available in the SJSU library databases and other online sources. One source must be an academic or professional book on your topic. Also include at least five credible website sources, at least one from each of the following domains: .gov, .org, and .edu. Sources from other domains are not allowed. For each source, include a correct APA reference citation.

Include the working title and proposed thesis statement of your paper. Type the references with hanging indent, and type the paragraphs in block indent beneath each reference.

c. Outline (5% pts.)

The purpose of this assignment is to come up with a plan for your paper that will help you organize your thoughts before you begin writing. Please choose an outline format that works for your particular writing process and learning style. No matter how your outline is formatted, **it is required that you include the major points you intend to make and use complete sentences rather than key words** (don't just list the general concepts you will cover, articulate what you plan to say about those concepts). All 21 references must be cited in the text of the outline. Include a separate reference list in APA style that includes all 21 references. This will show how each reference will support the sections of your paper.

Give the Outline a title that describes your literature review topic. Include your thesis statement.

d. Abstract (5% pts.)

Write an abstract in APA style for an empirical, academic, peer-reviewed journal article. I will provide a copy of the article. You must write the abstract for the article that I provide. Abstracts of other articles will not be accepted. Detailed information will be provided.

e. Problem Statement 1: Empirical (5% pts.)

Write the introduction of a proposal in APA style to conduct empirical research, which must include the statement of the problem; related background information from 10 academic sources, at least six of which are peer-reviewed journal articles; a description of one thing that is not known about the problem (what knowledge would be gained from your proposed research?); who will benefit from your proposed research; and a purpose statement. Detailed information on this assignment will be provided.

Length: 2-4 pages.

f. Problem Statement 2: Qualitative (5% pts.)

Write the introduction of a proposal in APA style to conduct qualitative research, which must include the statement of the problem; related background information from 10 academic sources, at least six of which are peer-reviewed journal articles; a description of what is not known about the problem (what knowledge would be gained from your proposed research?); who will benefit from your proposed research; and a purpose statement. Detailed information on this assignment will be provided.

Length: 2-4 pages.

g. Drafts of Literature Review Paper (12% pts.)

Draft 1 of the literature research paper must be in APA style and contain the following: a Title, Running Head, page numbers, an Introduction with a working thesis statement, at least three Level 1 headings that describe your topics, one paragraph of at least four sentences beneath each Level 1 heading, followed by at least three Level 2 headings that describe your three subtopics for each of the three topics, a Discussion and Conclusion section, applicable in-text citations, and a working References page. Include only the references that you cite in the text. At least one of the subtopics must relate to at least one of the diversity areas: age, gender, disability, sexual orientation, race or ethnicity, and/or socioeconomic status. All paragraphs will have at least four sentences. (3 pts.)

Draft 2 includes the same as Draft 1, plus at six subtopic paragraphs. To receive credit for this assignment, you must be present, submit it in class during the peer review session, and participate in the peer review. Include only the references that you cite in the text. 4-6 pp. (4 pts.)

Draft 3 includes the same as Draft 2, plus at six more subtopic paragraphs, for a total of 12 subtopic paragraphs. Include only the references that you cite in the text. 7-10 pp. (5 pts.)

h. Literature Review Paper (15% pts.)

The final literature review paper must include the following:

1. Ten to 15 pages of text, not including the References. Same as Draft 3, with an additional six subtopic paragraphs. Final paper will have at least three topic paragraphs, 18 subtopic paragraphs, an Introduction, and a Discussion and Conclusion section. There will be an average of four sentences per paragraph. Students will include in-text citations in APA style in the Introduction, all topic paragraphs, and all subtopic paragraphs. All 21 references must be cited in the text and included in the References section.
2. A focused and thoughtful thesis that involved challenging significant research.

3. Integrated diversity considerations and perspectives.
4. Synthesized information from a wide range of relevant academic sources, balanced and critically evaluated for credibility and objectivity.
5. Logical organization with unity developed from the thesis and clear connections among ideas.
6. Student's ideas integrated smoothly with paraphrased, summarized, and quoted material with in-text citations in APA style, and all conclusions clearly supported by relevant, convincing evidence.
7. Effectively communicated results of research that conveys an original understanding (student's voice) with clear, unified concluding ideas.
8. Clear writing with proper grammar, word choice, spelling, punctuation, mechanics, and consistently accurate APA format and citation style.

Length: 10-15 pp.

h. Oral Presentation (5% pts.)

All students are required to present their literature review paper. Presentations must be 10 minutes in length and must address what was discovered in the research and how it contributed to the academic discourse surrounding the topic. Presentations will be in PowerPoint or similar format.

Length: 10 pp.

i. Take-Home Tests (8% pts.)

The eight tests will include material from the APA book and from *Rules for Writers*.

j. Resume and Cover Letter Assignment (5% pts.)

Students must write a cover letter and a resume, which are specific to a job announcement. Details will be provided.

The copy of the job announcement and all pertinent information used to target the resume for the specific position will be turned in along with the cover letter and resume.

Length: 2 pages.

k. Class Participation: (5% pts.)

Students will work in groups writing practice abstracts and analyzing problem statements from journal articles. Students will participate in in-class editing of other students' papers. Students will answer questions about grammar and APA style that are asked by the teacher. Students will write on the board to facilitate learning APA citation and reference styles.

l. Final Paper: (20% pts.)

Students will write the final paper in class. The paper will be a short literature review in APA style that will include the following parts: Title, Running Head, page numbers, Introduction, three topic sections (with one paragraph of at least four sentences in each of these sections), Discussion and Conclusion, and References. The Introduction and Topic sections will contain in-text citations in APA style. The three topic sections and the Discussion and Conclusion section will have Level 1 headings. I will provide copies of web articles and

academic, peer-reviewed journal articles that will be the sources for this paper. The subject will be announced on the day of the final.

The course will be taught as a workshop. Your work will be reviewed by your peers. I project a student's paper and we edit it together, so your papers will be viewed and edited in class. There is no make up for in-class work.

Classroom Protocol

All written assignments, except the Business Writing assignments and the Oral Presentation, are to be in APA format, double-spaced, using Times New Roman 12-point font. Most written assignments must also be submitted to Turnitin.com.

Assignments will not be accepted late except in cases of documented emergencies.

- **Hard copies** of the assignments must be turned in by the end of class, 4:15 p.m. on the due date, to be considered on time.
- Remember to also submit your assignments to Turnitin.com.
- **Papers not submitted to Turnitin.com will receive zero credit.**
