Syllabus

Course Description: Selected ethical problems in health care practices. For example, abortion, patient rights, national health care, euthanasia and genetic engineering, with emphasis on philosophical methods.

Required Texts: *Bioethics: Health Care Law and Ethics*, Furrow et al eds. (HCL), *A Companion to Bioethics*, Kuhse & Singer, eds. (CB) There are 3 copies of HCL and 1 copy of CB on reserve at the library.

Requirements: One midterm, one final, one 5-7 page paper (due on the day of the final exam) and consistent participation. In order to get full credit for participation, you must come to class having done the reading, be actively involved in class discussion, and be able to give a thoughtful response when called on. Students who miss more than 4 classes will not get full participation credit unless they have a good reason for missing class. Students who miss 6 or more classes will not get more than 15 participation points, unless they have a good reason for missing class.

Grading: Participation 30 points, midterm 20, final 30 points, paper 20 points. As long as you have your topic and draft turned in on the due dates, you may rewrite your paper as many times as you wish and get the grade you got on the best draft.
