MSW PROGRAM APPLICATION – FALL 2010 INTRODUCTION

Welcome!

Thank you for your interest in the Master of Social Work (MSW) Program at San José State University (SJSU). Founded in 1969, and fully accredited, our MSW program has maintained an integrated and diverse student body. We equip MSW students for professional practice from a Transcultural Multi-Systems perspective: preparing them for culturally competent practice with Latinos, African Americans, Asian and Pacific Islanders, and those communities, groups, families, and individuals who are disenfranchised, oppressed, or marginalized. The unique transcultural perspective, which has historically guided the curriculum, promotes commitment of its graduates to enhance the well-being of individuals and their communities, to build upon the strengths of diverse cultures, and to advocate for social justice.

Applicant Prerequisites and Preparation

Applicants for admission to the MSW Program must demonstrate academic preparation and professional commitment to social work. Applicants must have:

1. **Undergraduate Degree.** Applicants must have an undergraduate degree from an accredited university in any field, although it is preferred that this undergraduate degree be in social work or a related field;
 2. **2.50 GPA or Better.** Applicants must have a minimum grade point average (GPA) of 2.50 in the last 60 units attempted;
 3. **Social Work Experience.** Applicants must have significant volunteer, internship, or paid work experience with groups such as Latinos, African Americans, Asian and Pacific Islanders, Native Americans, and other marginalized, oppressed, or disadvantaged groups;
 4. **Liberal Arts Foundation.** Applicants must have a foundation in liberal arts, usually achieved through general education or major coursework in the humanities, arts, and social sciences. Your transcripts and Liberal Arts Foundation Worksheet must demonstrate this foundation.
 5. **550 minimum paper-based, 80 minimum internet, or 213 computer-based TOEFL Score or 7.0 Minimum IELTS Score.** All applicants, regardless of citizenship, whose preparatory education was principally in a language other than English, must demonstrate competence in English. Those who do not possess a bachelor's degree from a post-secondary institution where English is the principal language of instruction must receive a minimum score of 550 on the Test of English as a Foreign Language (TOEFL) or a minimum score of 7.0 on the International English Language Testing System (IELTS).
- * **Human Biology.** Successfully completing a college-level course in human biology or qualified equivalency **is NOT required to apply.** However, if admitted and this competency is not yet acquired, students must complete an MSW Program-approved human biology course before entering their final year of the graduate program. To demonstrate equivalency in human biology, applicants must have completed course content in 5 key areas: (1) genetics/heredity, (2) human development, (3) human anatomy/physiology, (4) sexuality/reproduction, AND (5) aging. Your transcripts must demonstrate coursework or equivalency in human biology.
 - * **GRE.** The Graduate Records Exam (GRE) **is NOT required to apply.**

- * **Statistics.** A course in statistics is **NOT required to apply.** However, if accepted, students would benefit from knowledge in basic mathematical functions, algebra, probability, and statistics to succeed in our MSW Program.

Basic Application Information

If you are applying to our MSW Program, please note the following basic information:

1. Admission to the MSW Program is for the Fall Semester only.
2. Applications are accepted from **October 1, 2009 through January 8, 2010. Applications are not accepted after January 8th. Late or incomplete applications will not be reviewed.**
3. Admission to the MSW Program at SJSU requires **two separate applications**, which are:

A. **Application for admission to San José State University (available October 1, 2009).**

This first application must include:

- (1) **An SJSU graduate application completed on-line through www.CSUMentor.edu, including a \$55.00 application fee.** *
- (2) Official transcripts from all your college level education and any other required documentation. The transcripts must be in their original unopened University/College envelopes. *

* Please send official transcripts and other documentation to: Graduate Admissions and Program Evaluations (GAPE), San Jose State University, One Washington Square, San Jose, CA 95192-0016. To expedite the evaluation process at the GAPE Office, **we strongly encourage you to obtain and submit your official transcripts as soon as possible.**

B. **Application for admission to the MSW Program postmarked by January 8, 2010.** This second application must include:

- (1) MSW Program Application Cover Sheet, completed and signed;
- (2) Liberal Arts Foundation Worksheet;
- (3) Human Biology Requirement Worksheet;
- (4) Resume and Social Work Related Experience Worksheet;
- (5) Autobiographical Statement;
- (6) Three (3) letters of recommendation w/addendum (you may submit more than 3);
- (7) Three (3) self-addressed, stamped envelopes used to contact applicants;
- (8) \$25.00 MSW Program application fee made payable to the School of Social Work;
- (9) Either official or unofficial university/college transcripts (remember to also send copies of **official transcripts** for your SJSU graduate application detailed above); and
- (10) A sample of your best writing, i.e., a copy of a graded paper written for an upper-division or graduate-level class, technical report, or other example of your writing.

All required documents in support of your MSW Program application, including transcripts and letters of reference, **must be received no later than January 22, 2010.** Your application will not be reviewed until all required documents are received. Early application is strongly encouraged! You will be notified if an interview is required.

MSW Program Admissions Review

The MSW Program Admissions Committee evaluates each applicant on the basis of all submitted materials and information. Because admission into graduate degree programs is competitive and enrollment space is limited, many qualified applicants are not accepted into the MSW Program. The MSW Program Admissions Committee will notify applicants as soon as possible as to their status. These notifications, depending on the applicant pool and available space, can occur as early as March and as late as June.

Applicants admitted will be notified and sent an acceptance package. MSW students will be admitted to the full-time or 3-year program as indicated on the application AND according to available space. Applicants not admitted will also be notified, and must reapply the following year if they wish to be reconsidered for admission. **Admissions decisions are final and applications will not be reconsidered.**

Checking Admission Status: SJSU and MSW Program Applications

Applicants should periodically check their SJSU admissions status on-line through MySJSU. You can confirm if your SJSU-level application has been processed or if materials are missing. The MSW Program will notify you as to your application status via the self-addressed, stamped envelopes you provide as part of your application. **Admission to SJSU does NOT guarantee admission to the MSW Program.**

Conditionally Classified Admission

Students who do not meet the minimum GPA requirement of 2.50 may apply for conditionally classified status. The MSW Admissions Committee may consider applicants who possess strong or considerable work experience and who can remedy minor academic deficiencies by additional preparation.

Acceptance Decisions and Deferral of Admission

Applicants who are accepted but subsequently wish to postpone their MSW education at SJSU must also reapply the following year if they wish to be reconsidered. Admission deferrals may be requested, but are not granted automatically. Also, additional documentation and processing fees may apply.

Transfer of Credit and Course Substitutions

Academic credit for life and/or work experience cannot be given in lieu of the field practicum or for courses in the professional foundation curriculum. Students who have taken MSW-level courses at other universities may request a transfer of a maximum of 12 units of credit, but these requests must be made with the MSW Graduate Advisor prior to application.

Although we do not currently offer advanced standing, requests can be made on a case-by-case basis to substitute certain foundation level courses. Please place your request immediately after gaining admission to the program with the MSW Program Admissions Director and Graduate Advisor.

Taking MSW Courses Before Being Admitted

Only those admitted to the MSW Program may take graduate-level social work courses at SJSU; **MSW classes are NOT available through Open University.**

The unique transcultural perspective, which has historically guided the curriculum, promotes commitment of its graduates to enhance the well-being of individuals and their communities, to build upon the strengths of diverse cultures, and to advocate for social justice.
