Discussion: Controller Maldonado shared that Juver served with him within his fraternity as well as on the Operations committee last year and believes he would be a good addition to the Finance Committee. President Chuang asks Controller if he received any other applications to ensure we are reaching various student groups. Controller Maldonado shared that he has received other applications and some students have not been able to











meet yet and some he did not move forward with their applications. Director Gadoury highlighted that Controller Maldonado is very transparent with the applications in Finance Committee. Advisor Rugeley-Valle added that Juver served on the Finance Committee last year.

(President Chuang)


Discussion: President Chuang introduces President Teniente-Maston. President Teniente-Matson introduced herself and shared some of her background with the Board of Directors. She shares her educational journey as well as the institutions she has worked at.

Controller Maldonado is recognized at 3:13pm.

The Board of Directors introduces themselves to President Tentiente-Matson.

The Board of Directors asks President Tentiente-Matson a series of questions centered around her experience so far at San Jose State University, how she envisions working with the Board of Directors and the surrounding community, and how she would support and build new campus traditions. President Tentiente-Matson discusses campus safety.

Director Saif yields time to a member of the public. There is conversation about the future of parking and affordable housing on campus.











Director Varshney excused for Point of Personal Privilege at 3:36pm.

Further questions are asked regarding President Teniente-Matson's work so far with Native and Indigenous groups on campus as well as concerns around academic achievement across various student populations.

Director Varshney is re-recognized at 3:42pm.

6. Informational Item: Review of January Financials (Controller Maldonado)

Discussion: Controller Maldonado directs the Board to look at the January Financial Report and encourages them to think about the departments they work closely with to see how they are utilizing their funds. He highlights some variances across different departments and discusses what they might see change across the rest of the months of this Fiscal Year.

President Chuang asked for clarification regarding the UPD Grant and what it is for, and if it is different from the Transportation Solutions grant.

Director Herrlin asked why this was an informational item as opposed to a discussion item, as he feels it is important for the Board to be able to discuss and challenge what is occurring with spending. Controller Maldonado shared that it was not his intention to make it so that this could not be discussed and he would look at that when adding items to the agenda in the future. There is discussion as to whether this type of item should be an informational or discussion item.

# XII. Executive Officer Reports (4 minutes each)

- A. President
  - 1.Personnel Committee

President Chuang shares that she is meeting with President Teniente-Matson, Vice President of Student Affairs, Patrick Day and Vice President Rapanot and asks the Board to share items they would like to have brought to this meeting.











President Chuang is participating in interviews for the new CSU Student Trustees and has been invited to a tour with Santa Clara University. She created a document that contains important contacts for people that the Board may send letters of support to. President Chuang highlights that her office hours are Thursdays from 11-3 and she has found that many students are coming to her with concerns regarding student fairness, student safety, and accessibility issues. President Chuang shares that she is continuing meetings for the Mural Project. She thanks everyone again for attending the Day of Remembrance Event last week and highlighted its success.

#### B. Vice President

Vice President Rapanot is working on planning out A.S. 55 and the awards piece. He is working with A.S. Marketing.

#### C. Controller

1. Finance Committee

Controller Maldonado shared that \$79,351.16 have been approved for RSO funding. Controller Maldonado shares that he is working with the Finance Committee meetings to review and edit the budget policies. He has been attending his Academic Senate meetings.

#### XIII. Directors' Reports (3 minutes each)

- A. Director of Academic Affairs
  - 1. Academic Affairs

Director Saif shares that they have voted in a new student at large and will hopefully be able to complete more tasks in their committee. They have discussed working with marketing to encourage more students to join. Academic Affairs will be working with Programming Board on a de-stress midterms event. Director Saif has been meeting with his liaisons and discussing research opportunities and how to share those with students.

#### B. Director of Business Affairs

1. Operations Committee

Director Nikalwala shared that they had a meeting with Lezlee Matthews who supports with campus assessement. They discussed how they might be able to best utilize their surveys.











# C. Director of Co-Curricular Affairs1.Programming Board

Director Lacson shares that the Programming Board had a tabling recruitment event yesterday and they supported A.S. Events with their Valentine's event. She shared information about their tabling event, how it went, and how they will be evaluating it. Director Lacson shared that in March they will be working with the Academic Affairs committee on their de-stress event, as well as a thrift pop-up event. She shared that there are seats still available on the Committee on Committees. Director Lacson highlighted the Black History Month Movie night on Friday.

#### D. Director of Communications

Director Gadoury shared that A.S. Scholarships are live and encourages the Board to tell their friends. Director Aquino will be writing the next Spartan Scoop Blog. The Government Instagram collaborated with A.S. Marketing on a giveaway event. Director Gadoury shared that he is hoping to highlight office hours on Instagram. He is looking into re-creating a form where students can share concerns with the Board of Directors.

#### E. Director of Intercultural Affairs

1. Multicultural Advisory Committee

Director Aquino shared that the Multicultural Advisory Committee was not able to meet this week and is looking into rescheduling the meeting and will be engaging his liasions regarding this. Spartan Community Fund has approved \$6000.00 for Success Centers. Director Aquino has been and will meeting with various campus centers, students, and RSO's to determine support for groups.

Director Aquino highlights a Native American and Indigenous student experience event on Friday.

#### F. Director of Internal Affairs

1. Internal Affairs Committee

Director Herrlin shares that the Internal Affairs Committee is looking at the bylaws and what edits they would like to make for the 2023-2024 year. Director Herrlin highlights that they are looking at two large changes. One change they anticipate is adjusting committee roles for the directors, and making sure the work load is equitable across all directors.











Director Chadwick is recognized at 4:42pm.

He also states that they are looking at creating a discipline policy to include in the bylaws.

Director Herrlin shares updates from his Academic Senate Committee.

Director Herrlin shares that there is an organization called Turning Point USA that recently became an RSO, despite violating rules the Student Involvement has set.

# G. Director of Legislative Affairs

1. Lobby Corps

Director Treseler shares that he will be working on a subcommittee within Academic Senate. He shares that he discussed an opportunity for a Board member to go to the Capital with the President of SJSU to lobby. Director Treseler has been working with his liaisons, attended the CSU Chancellor Search, and has attended local swearing in ceremonies.

#### H. Director of Student Resource Affairs

1. Campus Life Affairs

Director Chadwick shared that Campus Life Affairs has planned a tabling event with the Student Alumni Connection. They are working on planning an art related event. He is supporting the Academic Affairs de-stress event. Director Chadwick shared information from his Academic Senate committee meetings. He shares that he is setting up meetings with his liaisons.

# I. Director of Student Rights and Responsibilities

Director Sheta shares updates from his committee with Associated Students and Academic Senate. He will be meeting with the Chief of Police this week and the Ombudsperson in early March.

#### J. Director of Sustainability

Director Varshney is working on the Earth Week Resource Fair. He will be meeting with A.S. Garden Coordinator Matt and Transportation Solutions manager Tiffany to discuss work for this semester.


