E. Executive Committee of the Academic Senate

- CR/NC has helped lower the number of students dropping out from the university or courses
- The CARES Act provides a lot of flexibility on how to spend it
- In the last Committee meeting, confidential information was discussed and cannot be shared in my report.

F. Instruction & Student Affairs Committee (ISA)

- The instructor drop policy was voted on to send to the board
 - The vote passed to take away the extra 48 hours for students to respond back to the professor that they are going to be dropped from the class due to not attending the first class period or not notifying the professor that they still wish to continue in the course
 - I made an amendment to add 24 hours to compromise which did not pass
 - All students were opposed to the removal of the 48 hours

A. Spartan Shops

- Spartan Shops applied for a Paycheck Protection Program (PPP) loan to help with employee wages
- The loan was approved for a little more than \$101,000
- The loan will be used to pay for employees in Property Maintenance and the Gold Complex
- The other two (2) departments under Spartan Shops (the Bookstore and Spartan Eats) don't receive the funding since they are private companies

B. Campus Fee Advisory Committee (CFAC)

- Voted in the last meeting to approve the redistribution of SSETF funds for the college of business and kept the distribution of SSETF for Athletics the same
 - Since the discussion of IRA would be a much longer conversation we decided to leave the SSETF as it is

- The next meeting with President Papazian will also be a transition meeting with the new A.S. President-Elect.

B. Patrick Day (Vice President of Student Affairs)

- The CARES Act fund for students have started to take applications
- Students who are international, undocumented, or were fully online prior to March 13th, 2020 cannot receive funding
 - This was not a university decision but a Department of Education decision from the federal government
- Funds should all be dispersed before the remainder of Spring 2020
- Any student who has a Family Contribution of \$10,000 or less will receive an automatic grant and does not need to fill out the form
 - If you have a Family contribution of \$10,000 or more, and need financial assistance to fill out the form as soon as possible
- Those who are not eligible should still contact SJSU Cares if they are facing financial insecurities and need assistance.

C. Charlie Faas (Campus CFO)

- Nothing new at this time

D. Vincent Del Casino (Campus Provost)

- The decision for Fall 2020 has not been decided yet.

- In the coming weeks, a decision will probably be made however, all options are being decided and are weighing the pros and cons of each decision
- It's not an easy decision since many things will be affected whichever choice is made

VI. Important Updates

- All the follow that is italicized is the same as my last board report but is still relevant
- The Campus Climate Survey has ended on May 8th, 2020
- The last day to receive Credit/No Credit (CR/NC) is on June 8th, 2020 after your final grades have been posted.
- New Title IX Rules will be implemented in August. I have read over all the new changes and urge the new board members to be aware of the new guidelines to help inform students
 - If you would like me to explain I can explain in depth 1:1
- *The Governor temporary suspended limited portions of EO 1037*
 - *Effective immediately, student course withdrawals earned during the spring 2020 semester or quarter shall not count against the maxima described in EO 1037*
 - *Students may subsequently repeat a course with a CR grade earned in spring 2020 for a letter grade*
 - *Units earned for a repeated course in spring 2020 shall be excluded from the 16-semester unit maximum for grade forgiveness*
 - *Campuses may allow students to repeat a course taken in spring 2020 even if the student has already attempted the course twice (B.2.b.)*
- *The limited suspension is sought to facilitate student progress toward degree completion.*
- *Hired Victoria Sexton as a case manager for SJSU Cares*
- *\$400k of basic needs funding awarded has been disbursed from the Chancellor's Office (CO) after some delays.*
 - *Work has started on implementing some of the program updates associated with the program proposal.*
 - *Rapid Rehousing funding has been delayed from the CO as we work as a system to put in place MOUs and Service Level Agreements with our off campus partners, the Bill Wilson Center. Work is continuously being done to move this project forward.*
- *SJSU Cares had 99 Request for Assistance forms submitted this quarter.*
 - *March 2020 had **38 cases** compared to **21 submissions in March 2019**. The majority of the recent cases have been students affected by COVID-19 from a fiscal perspective.*
- *Types of Assistance Requested (submission form asks students to designate what type of assistance they felt they needed):*
 - *68.7% selected 'Housing/Homeless Resources'*
 - *45.5% selected 'Financial Counseling/Resources'*
 - *27.3% selected 'Food Resources'*
 - *23.2% selected 'Employment Assistance'*
 - *12.1% selected 'Medical/Mental Health Assistance'*
 - *12.1% selected 'Other Assistance'*
- *On March 25th the pantry marked its one year anniversary of service to students experiencing food insecurity.*

- *Spartan Food Pantry had over 24,273 visits by 4,896 unique students.*
- *64% of visits have included fresh produce (70,495 lbs in total).*
