I. A.S. Committee Meetings

- A.S. Academic Affairs:

During this committee meeting, college representatives expressed they had or will be meeting with their respective college deans and associate deans.

The latter half of the meeting consisted of sharing gathered research (since the last meeting) on the use of online proctoring services in university institutions. The following are some of the points,

- **Faculty interviews:** some professors find that using online proctoring software is helpful during virtual learning and helps maintain academic integrity. However, other faculty members have recognized that there are other alternatives to the use of software and have conducted oral exams, essays, and used canvas for open-book quizzes/exams.
- The **privacy issue** of online proctoring software. A college rep. found several articles in which ProctorU and Proctorio are said to utilize live proctoring which can be concerning as students may not be aware that an actual person is on the other side of the screen watching them take an exam. On top of that, there have been concerns about security breaches that place students at possible risk of identity theft as students are asked, on occasion, to upload pictures of their ID.
- A.S. Internal Affairs committee: In this meeting, the agenda consisted of going over the recommended edits on Articles 3-4 of the Elections Regulation Manual (ERM) as well as going through articles 4 of the A.S. Bylaws. The chair has been using the comment feature on google docs to make suggestive comments and edits.

II. University Committee Meetings

- ISA (Instruction and Student Affairs Committee): ISA committee met on Monday 10/19 and went over policy recommendations that were brought to the main committee. As a collective, the committee delved into policy recommendations on excused absences and focused on the wording of lists that would constitute appropriate absences. There were concerns about whether this policy was needed in the first place due to the nature of overwhelming number of existing policies but inefficient awareness of them. There was controversy as to whether “travel for work” should be included in the list of possible excused absences. While some members and students supported this saying that these situations should be dealt with on a case-by-case basis, others raised concerns that this could lead to favoritism.

- The University Task Force on Community Safety and Policing met on 10/22. Members shared insight from the articles posted on the shared drive. Members agreed to hold a community meeting(s), reach out to several organizations on campus (i.e. BSU, Undocumented students, housing services), and create an online platform for questions, concerns, and comments to be brought to the task forces. Talk surrounding what “safety” means on an urban campus led the

team to discuss possible extensions to gather insight from an outside consultant to better draw recommendations for the university.

- Met with Gis Thompson, SCED Associate Director regarding collaboration for an event in November.
