Safety protocol appropriate to working with hazardous chemicals. Physical nature of hazards, biological effects, permissible exposures, safety precaution techniques, OSHA requirements, storage and segregation of chemicals.

**CREDIT/NO CREDIT** grades will be assigned for Chemistry 120S. To receive credit, students must score at least 80% on their *cumulative* work.

**Score Weighting:** Scores are unweighted in computing the final grade.

**Late work:** Note that quizzes and exercises are due on regular intervals. But, they are all *open* until late in the semester. You may turn them in for full credit until the *close* date. After this date, work is not accepted.
