The Department of Counselor Education seeks to fill a position at the Assistant/Associate level to meet the needs of students seeking a master's and/or credential or professional licensure in one or more of the following program emphases: Pupil Personnel Services, Higher Education, Career Counseling, and Licensed Professional Clinical Counselor

An earned doctorate in Counselor Education, Counseling Psychology or a related field is required by time of appointment. Successful candidates must demonstrate knowledge in teaching, research, and clinical skills related to one or more of the following emphases in the department: Pupil Personnel Services, Higher Education, Career Counseling, and Licensed Professional Clinical Counselor.

Candidates applying at the Associate Professor rank should have a record of published research, teaching excellence and professional achievement appropriate to the rank.

Applicants should have awareness of and sensitivity to educational goals of a multicultural population as might have been gained in cross-cultural study, training, teaching and other comparable experience.

**Responsibilities:**

Candidate must address the needs of a student population of great diversity – in age, cultural background, ethnicity, primary language, and academic preparation – through course materials, teaching strategies and advisement; teach master's level courses in Counselor Education; supervise students in practicum and field work, advise students, participate in University committees and community service; initiate research, grants, and other scholarly activities.
