Course Description

Computing topics of current interest in industrial practice. This class focuses specifically on database implementation and DB2 for z/OS Application Development.

The DB2 section is divided into 2 parts:

- Part 1 Programming APIs for DB2 for z/OS
- Part 2 Exploitation of SQL Functions

Your program needs to be able to compile and execute before you turned it in.
