Course Description

In this class, we will make video games! This class covers using an existing game engine to make games, focusing on using the Unity3D game engine. There will also be discussion of how other engines are organized. By the end of the class, students will have made three video games. At least one of these games will be done as a group.

3. SLO 3 Make a game with a team in Unity3D

Course Requirements and Assignments

Instead of tests, there will be projects.

Grading Policy

Grades will be based on the percentage of total points earned:

C- = 70% - 72% D+ = 68% - 69% D = 60%-67% D- = 50%-59% F = 0% to 49%

Late Assignments
