VERIFICATION FORM

The California Education Code and Title 5 Regulations specify, in most cases, that applicants for a credential, certificate, or permit to serve in the public schools of California must verify basic skills proficiency before the credential, certificate, or permit will be issued. CTC accepts different options for meeting the Basic Skills Requirement. If you are choosing an option other than CBEST or the CSET Writing Skills Examination, it must be verified and approved by a credential analyst in the Credentials Office. If approved, keep a copy for your records. You will be required to submit it along with a copy of your official exam score report and/or transcripts at the time of filing for your initial teacher certification at the end of the program.
