I. Feedback from Advisory Board

- Discussed that each college create a resource center for flipping faculty, and faculty who are interested in the flipping pedagogy (a home base).
- CSULA (Silvia) runs a flipping faculty hub/ Community on campus, already.
- Discussed the possibility of the Calculus student survey be used outside of calculus courses. If possible to re-purpose the Calculus survey for other courses, we would be able to compare responses across different disciplines.
- If we keep the survey anonymous also, would not have to write new IRB.
- CSULA has brainstormed some questions, already, and Shandy said she will provide a link to share input from CSULA.
- Alma/Shandy discussed the time-line for the next WestEd report that will be presented in May at the Spring Board Meeting.
- Shandy will begin analyzing data from mid- to late January; in February they will give a Calc-study update, and then in March they will review the report that will be presented to the Advisory Board.
- Board would like a report on "in-class" observations of flipping. WestEd has done some
 of this.
- Alma would like to develop interview questions for the FLC project team to create protocols to get the "pulse" of "stake holders".
- Discussed when April board meeting should take place; picked a tentative date for late March/just before spring break.

II. Mini-Grant Review

- Tyler has shared with the Leads and FLCs the submitted mini-grant applications (9-CPP), (6-CSULA), (12- SJSU). Reviewed faculty applications and clarified unique questions concerning particular applicants.
- Silvia was very impressed by the CSULA applications; SJSU had a much better response than last summer's mini-grants.
- Laura reiterated that no graduate classes would be awarded a mini-grant and also reminded everyone to make sure we are aiming for 50% flipping (50% new flipping material, reevaluation and re-development).
- It was suggested and discussed to make Webinars available for faculty that would demonstrate flipped classroom activities.

III. FITW APR

- The FITW APR is undergoing its final review process. Once approved will be submitting to the Department of ED.
- Big thank you to everyone submitting the data to Tyler to complete the APR
- Reminder that we will need the rosters with the grades from Fall 2018 when they come in at the beginning of next year.
