Case Creation Date:

- April 22, 2025

Incident Summary:

- *It was reported to our office that on or about 4/18, your fraternity accessed the Morris Daily Auditorium without permission to hold an unauthorized event.*

Student Organization Code of Conduct Violations:

- (1) Aiding and Abetting:
 - (C) Encouraging, permitting, or assisting another to do any act that could subject him or her to discipline
- (5) Disorderly Conduct:
 - (C) Excessive noise which is disruptive to the campus or surrounding community.
- (8) Failure to Comply
 - (A) Failure to comply with the directions of University officials acting in the performance of their official duties.
 - (C) Failure to follow all policies and procedures established by the University pertaining to student organizations, including fraternities and sororities, as outlined in the Student Organizations Handbook.
- (20) Theft:
 - (A) Theft of property or services on the University campus or at sponsored events.
- (21) Trespass
 - Entering any university facility except in accordance with established policies and procedures.
- (23) Violation of Student Organization Conduct Procedures and Sanctions including:
 - (G) Failure to comply with the sanction(s) imposed under a student organization discipline proceeding which may result in further disciplinary

action and/or additional sanction(s).

- (24) Violations of Civil or Criminal Law
 - Student organizations in violation of local, state or federal law are in violation of the University Code of Conduct. University sanctions for such violations may be imposed independent of and prior to the disposition of any legal proceeding in a civil or criminal justice case.

Sanctions:

- **Probation at the University extended until December 31, 2026.** Probation is entered on the Student Involvement website with beginning and end dates.
- **Complete an in-person workshop hosted by Pi Kappa Phi Fraternity and Student Conduct and Ethical Development on or before September 30, 2025.** You must complete the in-person workshop “Ladder of Risk”, hosted by a representative of Pi Kappa Phi and a representative of the office of Student Conduct and Ethical Development. This workshop should be attended by no less than 80% of your current membership, including any new members associated with your organization. Ensure that documentation of the workshop and a roster of attendees is submitted to Student Conduct and Ethical Development.
- **Create a Video Training on Reservations before September 30, 2025.** This training should teach all student organizations how to successfully reserve spaces on campus and should be of sufficient quality to be released to all student organizations as a training tool. Topics covered should include the following, as well as any other topics you feel would be relevant: How to reserve room spaces, tabling spaces, or reservation resources such as canopies and etc. Advice on learning and following rules and restrictions for any reservation spaces. Any other information you feel would be helpful to student orgs looking to reserve items on campus. This training video should be submitted to Student Involvement and Student Conduct for approval. To ensure that you develop a strong product, you are encouraged to work with those offices throughout the development process. You are also encouraged to consult with any on-campus offices that manage reservation processes. This training video should be an activity completed by the fraternity, rather than the work of one individual. To that end, you will need to submit a credits page listing who worked on what part of the video to ensure that multiple individuals participated in the creation
