

## **Summer Session Options**

### **On-Campus Housing at SJSU**

#### **Current Spring Residents:**

Current residents will transition from their current spring assignment and may stay until August 20, 2016, which is the opening of the 2016-2017 academic year (licensed and paid returning residents), or until August 6, 2016 (not licensed residents for the 2016-2017 academic year).

Current Classics or Suites residents who are returning for the 2016/2017 academic year should select option #1 Summer Classics/Suites Returning Fall (May 25 to August 20, 2016).

Current Classics or Suites residents who are not returning for the 2016/2017 academic year should select option #2 Summer Classics/Suites Not Returning (May 25 to August 6, 2016).

Current CVA or CVB residents who are returning for the 2016/2017 academic year should select option #3 Summer CVA/CVB Returning Fall (May 29 to August 20, 2016).

Current CVA or CVB residents who are not returning for the 2016/2017 academic year should select option #4 Summer CVA/CVB Not Returning (May 29 to August 6, 2016).

Current Faculty or Staff residents of CVA who are returning for the 2016/2017 academic year should select option #5 Summer Faculty Staff Returning Fall (May 29 to August 20, 2016).

Current Faculty or Staff residents of CVA who are not returning for the 2016/2017 academic year should select option #6 Summer Faculty Staff Not Returning (May 29 to August 6, 2016).

#### **New Summer Residents:**

On occasion, new 2016-2017 academic year residents may start living with us in the summer. If you plan to be here for a summer session, and wish to continue living on campus right up until August 20, 2016, the official opening of the 2016-2017 academic year, please contact us at [uhs-frontdesk@sjsu.edu](mailto:uhs-frontdesk@sjsu.edu) or (408) 795-5600 for additional information.

Students attending the first 5 week summer session should choose option #7 Summer 5 Week June 5 to July 9

Students attending the second 5 week summer session should choose option #8 Summer 5 Week July 10 to August 13

Students attending the 10 week summer session should choose option #9 Summer 10 Week June 5 to August 13

**Payment Information:**

UHS does not charge an application fee for the summer period. Once an online application has been finalized (electronically signed license agreement and \$600 initial housing payment), your housing application is considered complete and will be considered for a space for the summer term. The completed online housing application and \$600 initial housing payment priority due date is April 18, 2016 to be included in the initial room assignment process.

The remainder of the summer fees are due on May 9, 2016. You may review the summer session rate charts linked below. Applicants submitting an online housing application on or after May 9, 2016 will be required to submit the entire summer payment at once. Applications will not be considered complete until the entire summer payment has been remitted.

Faculty and Staff will continue monthly payments and may refer to the summer rate charts.

All summer residents of University Housing Services are eligible to purchase a Campus Village parking permit (based on space availability). These permits allow parking only in the Campus Village parking garage. If residents would like to park in other on-campus lots, a campus parking permit may be purchased from Parking Services online, only the Campus Village parking permit may be purchased from University Housing Services.
