

Justice Studies 4-Year Advising Guide

To help you understand our JS curriculum and to successfully plan your JS experience, here is essentially what every student needs to complete in order to graduate with a major in Justice Studies:

1. Lower Division GE
 - a. Please see Student Services or the CASA Student Success Center (MH533) on MH 5th floor for advising on lower division GE coursework.
 - b. Take two necessary "support courses" 1. JS 10 or equivalent (or JS 12, JS 25 or FS 11) and 2. STAT 95 or equivalent (or JS 15).
2. Major Courses
 - a. JS 100W should be completed as soon as possible – Not taking JS 100W early delays graduation; 100W is a prerequisite for most upper division courses in the major.
 - b. Take all required upper division JS courses (they are marked with an asterisk "*" on the Major form): JS 151, JS 114, JS 101, JS 102, JS 100W, JS 189 (or FS 169), and JS 181 (or JS 141).
 - c. Take the mandatory minimum, but no more than the maximum, units in each JS core competency area (Areas: A-F). Students should feel free to choose from the options available in each area, depending on their career and educational goals.
 - d. In total, each student must complete 45 units (typically 15, 3-credit courses) of upper division JS coursework. *Note: this cannot be achieved by simply completing the mandatory minimum units for each competency area, so make sure to count up your courses carefully.*
 - e. JS 189 may be taken only in the final semester at SJSU
3. SJSU Studies
 - a. Each student must also complete SJSU Studies Courses (Areas R, S, V, and Z). [Please see the SJSU Course Catalog and/or the SJSU website for a list of all SJSU Studies Courses info.sjsu.edu/web-dbgen/narr/schedules/rec-12788.12993.13000.html.]
 - b. JS 100W counts as the Z course.
 - c. Students may take one of the S or V courses in JS (It will satisfy major and SJSU studies requirements). JS Area S courses: JS 132 and JS 136. JS Area V course: JS 171
4. Complete 120 units of coursework
 - a. All students must complete 120 total units in order to graduate with an undergraduate degree.
 - b. Students may take any desired course to bring unit count to 120 – these are considered "university elective" courses
 - c. Often, a minor is a good use of elective courses

We strongly encourage students to meet with their assigned advisor at least once a year. Be sure to review the JS Student Handbook and the other student related materials on our website.

Justice Studies Undergraduate Program: Core Competencies

A: Theories (9-12 units)

Theories in Justice Studies offer ways of analyzing, explaining, and critiquing our world and social institutions. Students will learn various theoretical approaches to concepts of power and justice, which lie at the heart of struggles for justice and the resistance to injustice in the modern world.

Courses: *JS 103, JS 104, JS 132(s), JS 151*, JS 153, JS 155, JS 157*

B: Methodologies (6-9 units)

Methodologies refer to the ways scholars gather and evaluate knowledge in Justice Studies. The term “methodologies” includes research methods (the procedures used in research to collect or generate data) and the philosophical assumptions on which a study is based and certain methods are chosen.

C: Critical Inquiries into Law, Justice & Society (6-9 units)

Critical inquiries involve the ability to ask relevant questions that challenge authority and orthodoxy as they help students to construct and synthesize knowledge, and analyze phenomena in a multi-faceted manner. Critical inquiries as a competency area enable students to evaluate justice issues and theory not at face value, but as an intersection of competing or colluding forces that are not initially evident. Critical inquiries help students to become active agents in society as they critique our social world.

D: Local, Transnational, and Historical Analyses (6-9 units)

Within this competency area students will learn how to contextualize justice-related issues using subjects and theories connecting local, transnational, and historical analytical frameworks. That is, students will develop the empirical, methodological, and analytical skills to understand how a justice-related practice or problem affects or has affected different communities, societies, and cultures of the modern world.

E: Analytical Research and Writing (6 units)

Within this competency area students will develop the skills to conduct and evaluate scholarly research and writing, including the identification of scholarly and non-scholarly sources. As they assess the strengths and limitations of research, students will engage in erudite and persuasive writing and presentation for a professional or academic audience. Students will learn to support arguments with relevant sources, and to cite them according to applicable professional standards in the humanities, social sciences, or sciences.

Courses: *JS 100W*(z), JS 189* or FS 169*

F: Experiential Learning (3-6 units)

Justice Studies promotes scholarly and applied understandings about the interaction between theory, scholarship and human experience. The Department encourages experiential learning that draws from and seeks to serve local communities around the Bay Area and beyond.

Special Topics (Areas A-D; 6 units maximum)
