CORRECTIONS AND SOCIETY

COURSE DESCRIPTION:

Corrections and Society is a multidisciplinary study of corrections from the 1800's to the present. Significant studies relating to the role of corrections, methods of community treatment, and analysis of correctional models and practices will be covered.

OBJECTIVES:

1. To briefly review the history and philosophy of punishment and the development of corrections in the United States.
2. To discuss corrections as a component of the criminal justice system and its interrelatedness with law enforcement and courts.
3. To examine the correctional alternatives available.
4. To examine the administration of correctional agencies.
5. Emphasize issues in correctional institutions for males, females, well as institutions for juveniles.
6. To briefly take a cross-cultural view of corrections.

The books are available at the Spartan bookstore and Roberts. Other readings may be assigned to supplement the text. These will be placed on reserve in the library or made available to the student in class. A reading list is also supplied for those who are interested in additional reading.

Students are also expected to keep up with recent developments in corrections by reading a daily newspaper such as The San Jose Mercury News, The San Francisco Chronicle, The Los Angeles Times, or The New York Times. You are encouraged to contribute to class discussion regarding current issues in corrections.

A DISCRIPTION OF THE EVENTS OF THE FILM IS NOT SUFFICIENT. Cite references from the text and other readings from the periodical literature.
