### **Course Description**

As an introduction to American criminal courts, their history, purpose and process, this course will survey the federal and state courts, their general constitutional structure and function with an emphasis on procedures, including criminal investigations, arrest, arraignment, grand jury, indictment, pretrial, trial, conviction, acquittal, sentencing and appeal. In addition, the course will examine the role of prosecutors, defense attorneys, judges and probation officers throughout the criminal courts in the United States.

Prerequisite: Upper division standing.

A grade of "C" or better is required for Justice Studies' majors.

On completion of the course, the student will understand:

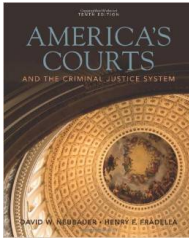
**LO1** – the history, purpose and process of the American criminal justice system.

## Assignments and Grading Policy

*Chapter Prompts* – For each chapter, the instructor will post questions for students to respond. Generally, the questions require a response that shows that the student understands the course material. Responses for the short essay prompts must be no longer than 150 words. Please dedicate time to this course. **DO NOT FALL BEHIND.**

The purposes of the prompts are:

- 1) To have students think critical regarding issues.
- 2) To keep the students on track and focused on the course material. The Critical Thinking Prompts will cover one or two chapter from the text. Students must submit their responses daily. The instructor will not accept late assignments.

*Examinations* – There will be a midterm and a final examination. Each will consist of approximately 40 multiple-choice questions and two (2) short-answer/essay questions. These will be open for a 24-hour window (midterm on Friday, January 9, 2015 and the final on Friday January 16, 2015). The examinations will be timed. Students will have approximately 75 minutes to complete the exam.

*Class Participation* – Points for class participation will be awarded pursuant to the quantity and quality of the student’s contribution to the Discussion Topics. PLEASE NOTE—the amount of points awarded is at the sole discretion of the instructor.
