Course Description

Examines the historical and philosophical development of the justice system; description, analysis and evaluation of criminal justice agencies, and explores the relationship between theory and practice. Note: Must achieve a grade of "C" or better to fulfill Justice Studies major requirements.

Upon successful completion of this course, students will be able to:

CLO 1: Provide an introduction of the characteristics, structure, and processes of justice system operations in the United States.

CLO 2: Explain criminology, criminal law, criminal statistics, and constitutional criminal procedure as it relates to practices within the justice system.

CLO 3: Describe and discuss the purpose, functions, critical issues, and societal interactions of the three major components of the justice system, which includes the police, courts, and corrections.

Course Requirements and Assignments

Success in this course is based on the expectation that students will spend, for each unit of credit, a minimum of 45 hours over the length of the course (normally three hours per unit per week) for instruction, preparation/studying, or course related activities, including but not limited to internships, labs, and clinical practica. Other course structures will have equivalent workload expectations as described in the syllabus.

Weekly Assignments (30% of final grade)

Students will be assigned weekly reading and writing assignments in class and as reflected below. Weekly assignments are due during Wednesday class sessions, or as instructed, and will consist of a one-to-two page double spaced typed analysis in 12 point font (CLO 1, 2, 3)

Quizzes (30% of final grade)

Students will complete a total of seven quizzes throughout the semester to be administered at the conclusion of class on specified Wednesdays (as reflected below) in response to subject matter from readings, assignments, and lecture. Missed quizzes may not be retaken for quizzes for credit without a documented excuse or by the discretion of the professor (CLO 1, 2, 3)

Final Exam (30% of final grade)

Students will take a final exam (worth 30% of your final grade). We will discuss the formats of these as we get closer to examination dates (CLO 1, 2, 3).

Participation (10% of final grade)

Students are expected to be in each class, on time, having read the assigned readings in order to facilitate robust, informed discussion as a class (CLO 2, 3)

Grading Information

We will discuss grading in class prior to every assignment. Students are encouraged to ask questions to ensure they understand expectations. Rubrics will be provided on Canvas or in class for every assignment.

Grades will be used along with substantive feedback to indicate students' performance in a variety of tasks. Exams and final grades will be calculated as a percentage on a typical "100 point scale." Please note, a "C" or higher is required to receive credit for this course toward a Justice Studies or Forensic Science Major. Passage of the Writing Skills Test (WST) or ENGL/LLD 100A with a C or better (C minus not accepted), and completion of Core General Education are prerequisite to all SJSU Studies courses. Completion of, or co-registration in, 100W is strongly recommended. A minimum aggregate GPA of 2.0 in GE Areas R, S, & V shall be required of all students.

Classroom Protocol

Attendance/Punctuality

Regular attendance and punctuality are encouraged. Students who are routinely inattentive, discourteous or who choose not to contribute to in-class discussion and/or activities, will be noted and may result with up to 10% deducted from the final grade.
