COURSE OBJECTIVES

This course will provide a study of law enforcement development from the mid 1900s to present day. Students will learn about the evolution of police work and its transformation from basic police services to modern day practices such as regional policing and the development of community partnerships to combat crime. The course will also cover aspects of Police Management, Patrol Operations, Selection and Development and Accountability and Ethics.

CLASS SCHEDULE

The class will meet each Thursday afternoon from 5:30 PM until 8:15 PM. The lecture and reading assignments are tentative pending class discussion, guest speakers and overall pace of the class. (See reverse side for class schedule.)

GRADING

Students will be graded on a <u>100 point system</u>. (100-90 points = A, 80-89 points = B, 70-79 points = C), the points will be awarded according to the following guidelines:

- 1. <u>One midterm exam</u>, Thursday, <u>October 3, 5:30 PM</u>, worth <u>30 points</u>.
- 2. One final exam, Thursday, December 12, 5:15 PM, worth <u>30 points</u>.
- 3. One group oral presentation, (3 people per group) worth <u>30 points</u>.
 - 10 minutes on any related topic of policing (subject to approval by instructor)
 - Students must prepare an outline and source page which must be turned in the day of the presentation.
 - Prepare one multiple choice question (on a separate piece of paper) from your presentation which I may use on either the midterm or final exam. Include your names on the question page for future test reference.
- 4. <u>One "Leadership Quote of the Day,"</u> written and presented to the class. Each student will prepare the "Quote" on a single piece of paper, explain his or her interpretation of the quote and then present the same to the class. Two students will present each day worth <u>10 points.</u>
