Interdisciplinary examination of issues of race, class, gender, ethnicity, economy, and culture as it relates to punishment, the penal process, and social control.

Course Success

Written Assignments

Canvas Discussions

Students will be required to post original comments, and replies to other students' comments, in response to topics posted by the instructor in the *Discussions* component of Canvas. Chosen topics will directly relate to readings. A set time frame will be in place for posting of comments and replies, students will only be able to post during said time frames. Full credit (i.e., points) for each posted topic will require at least (2) substantive posts, one original post and one reply to another student's post. See course schedule and check canvas. Exams

Students will be required to complete two online, essay-format exams via Canvas covering assigned course readings and lecture material. [CLO 1-6]

Final Project: Addicted to Incarceration (ATI) Analysis Paper
