# **Course Description**

Interdisciplinary exploration of human rights instruments, institutions, and notable human rights campaigns. The historical development of human rights and contemporary threats to the realization of fundamental dignity for humans and non-humans will also be explored.

# **Section Description**

This course will explore in a comparative and interdisciplinary way the militarized border conflicts of the USA-Mexico Border and the Israel-Palestine Region. We begin with an analysis of the USA-Mexico border and explore the history of the region, issues of security, racial profiling, and the criminalization of immigrants. We continue with an exploration of the Israel-Palestine conflict beginning with the historical context of the region,

issues of colonialism, social control, and how border violence impact Palestinian women and children. We conclude with a comparative analysis of these two sites.

# Justice Studies Department Reading and Writing Philosophy

CLO 1: Evaluate the historical contexts of political ideas and cultural traditions associated with border conflicts. Students will achieve CLO1 through Writing Assignments, Lecture Notes, and Quizzes.

CLO 2: Describe effects of border conflict on communities and individuals. Students will achieve CLO2 through Writing Assignments, Lecture Notes, and Quizzes.

CLO 3: Compare systematically the political and strategic practices of agents associated with resistance and border control. Students will achieve CLO 3 through Movie Review Discussion Board and Final Student Essay.

# \*\*\*\*\*Due to Covid-19, I will drop the two lowest grades for Qs and LNs and one lowest grade for the WAs. This is 3.5 weeks' worth of work!!! Please use this generous drop policy as best as possible as support for these turbulent times. \*\*\*\*\*

**Lecture Notes (LN)-** For each reading, I will review the major concepts. Take handwritten notes on these sessions to help you prepare for the Final Student Essay. See detailed instructions in Canvas for this assignment.

Writing Assignments (WA)- These writings are abstracts of the reading assignments. These WAs will prepare you for the Final Student Essay. See detailed instructions in Canvas for this assignment.

**Quizzes (Q)** - These quizzes test that the student has read the assignment from start to finish and understands the underlying structure of the argument as well as its finer, more critical points. These quizzes will prepare you for the Final Student Essay. **Quizzes must be completed by the due date/time, or the short answers will not be graded**. Please use a printed hard copy of the reading as your notes for the quiz. You will have to show that to the webcam each page of your reading printout for recording purposes before the start of the quiz. Please highlight key facts the author's is emphasizing in the reading. Use the subheadings to help you determine the most important info in each sub-headed section. Pay attention to the thesis statement in the intro section. Annotate/ put notes on the sides of the printout and try to anticipate T/F, short answer, and multiple-choice questions. I would re-read the article one more time before you take the quiz to improve your reading comprehension and your test taking ability. See detailed instructions in Canvas for this assignment.

**Movie Review Discussion Board (DB)-** These assignments are designed to help the student collaborate with other students by means of discussion in developing a more thorough understanding of militarism, borders and conflict. You will watch one movie on the USA/Mexico Border and one movie on the Israel/Palestine Border. See detailed instructions in Canvas for this assignment.

**Final Student Essay (FSE)** – This essay will serve as your final exam and culminating project for this course. See schedule below and on Canvas. This assignment will be due at the end of the final exam time for this class.

Success in this course is based on the expectation that students will spend, for each unit of credit, a minimum of 45 hours over the length of the course (normally three hours per unit per week) for instruction, preparation/studying, or course related activities, including but not limited to internships, labs, and clinical practica. Other course structures will have equivalent workload expectations as described in the syllabus.

A paper or project will receive an F if two or more of the following conditions are satisfied: The paper contains significant or serious grammatical, typographical, or spelling errors; it is not clearly written or logically organized; the train of thought is difficult to follow; the depth of coverage of the topic is not adequate; the information presented is inaccurate; the style and/or format of the paper are not appropriate to the assignment. The paper will also receive an F if some or all parts of the paper have been plagiarized, as defined later in this

syllabus/syllabus. For quizzes, the grade scale is based on the number of questions answered correctly on a point system.

# **Classroom Protocol**

1) I drop the two lowest grades for Quizzes and LNs and one for the WAs. This is 3.5 weeks' worth of work to help with the burden of the pandemic. This policy provides great flexibility for students to cover things like: uploaded the assignment to wrong folder, added the class late, uploaded the assignment in .pages, .rtf, etc. and not in required format, uploaded in multiple files when one file is required, did the assignment on the wrong reading, lecture, or quiz, got sick but did not visit doctor for 3<sup>rd</sup> party documentation, job and family demands, lost WIFI/computer crashed during the quiz, started the wrong quiz, got red-flagged multiple times by lockdown browser, etc. Canvas automatically configures the lowest grade drop policy in its grades. Use this generous privilege prudently.

2) Late work beyond what is covered in the lowest grade drop policy is only accepted with a **3<sup>rd</sup> party documented excuse with signature/ full contact information/date range the excuse covers**. You must **notify me ASAP by email about your situation** and keep any documentation for use as a 3<sup>rd</sup> party documentation for late work, that **should be uploaded with your late assignment** onto canvas.

3) Remember, technical difficulties are the students' responsibility so get work done early to avoid last minute challenges. You can access assignments early to help you negotiate your time, but **deadlines are firm**. In the case that a technical difficulty occurs beyond the student's control, the student must asap 1) take a screenshot to document the difficulty if possible 2) seek the help of the ecampus support desk (https://www.sjsu.edu/ecampus/how-we-can-help/contact-us.php) and 3) inform the instructor of the issue by email. If the help desk support determines that the technical snafu was beyond the student's control, the help desk could serve as the 3rd party documented excuse of the late assignment.

4) You must have regular and unfettered access to high-speed internet, a computer/laptop with webcam, printer access, word processing software, and software and hardware requirements that meet Canvas platform needs. **Do not attempt to manage this class or do any assignments on your smart phone/device/tablet.** 

5) Writing assignments must use Times New Roman font [not Times] and be in .doc or .docx format only. Students are encouraged to use the Word software that is available at no cost to SJSU students. Visit <u>Microsoft</u> <u>Office 365 Portal</u>. You can access the Office 365 Portal with your SJSU Email address and SJSUOne Password if you are an enrolled student. Word software has superior grammar and spell check to Google Docs and other programs/apps and will help improve your grade in that area.

6) Any violation of the Academic Integrity Policy will be reported to the Office of Ethical Development and will result in the failure of that assignment or even the course: <u>University Academic Integrity Policy F15-7</u> [pdf]. Turnitin.com is used to determine plagiarism on all assignments in canvas except quizzes. If you turn in something that exceeds 15% in plagiarism from any one source, you will fail the assignment immediately and you (and if you plagiarized from another student, that person you plagiarized from) will be reported to student conduct for investigation. So not share your graded work with other students and do not post on cheating websites or you could be reported for student misconduct if caught. **Turnitin.com flags plagiarism through color coding and only blue and green are acceptable assessments of your work**. In some cases, a student may fail the course if the plagiarism is repeated or particularly egregious. A Turnitin.com tester is provided that allows you to find out your plagiarism score before you turn in your assignment. Please use this tester before turning in any writing assignment to avoid accusations of plagiarism. You cannot use any prior assignments in any course [this is self-plagiarism] and you must start from scratch, even if you failed this class prior and are taking it again. Do not plagiarize and properly use the American Psychological Association (APA) 7<sup>th</sup> edition to cite sources on all assignments. There should be no quotes in the WAs given that they are a paraphrasing exercise only. Avoid quoting in the FSE as well to align with APA citation and writing standards. I will not grade any writing assignment that does not have a Turnitin.com score/ report generated so it will be the student's responsibility to resolve any technical issues with ecampus if problems arise.7) Students are required to read the feedback that I give on graded assignments. I provide feedback to help you improve on your assignments. Your grade will be affected if you are not reading and improving from the feedback provided. Typically grades and/or feedback will be provided within 14 calendar days [not including holidays].

8) Respondus lockdown/webcam will be used on all quizzes. Before the start of the quiz, Respondus lockdown will require an environmental check where you need to provide **a view of your ID and the immediate work area** where you will take the quiz and show that there are **no devices** accessible to you in your workspace via your webcam. If you want to use a copy of the reading for the quiz, you will have to show that to the webcam. You will not be able to use any other materials besides a printed hardcopy of the reading for this quiz. Please flip through each page of the reading to the webcam for recording purposes. Any egregious or multiple breaches in the Respondus lockdown protocol can result in a zero for the quiz, which you will have to use your lowest grade drop to cover. Repeat breaches may result in an F for the course.

9) I will review emailed drafts of most writing assignments attached as a Word document between 9am-10am on a 1<sup>st</sup> come, 1<sup>st</sup> serve basis by email the day before your assignment is due. This is highly recommended but not required.

10) Check canvas announcements frequently for reminders about due dates and any additional instructions or modifications to assignments. You will be responsible for all communication via canvas announcements and emails.
