# **Course Description**

For this project, a substantial paper of a justice agency program, justice policy, and/or organizational issue is required. The contents will be determined by the student in consultation with the instructor, with whom the student meets regularly for supervision.

#### **Course Format**

This is an online graduate level course and is designed to emphasize critical thinking and developing analytical perspectives to an approved justice studies topic. The duration of the course will focus on completing sections of your Applied Project. You will also have the opportunity to present your research to the class and provide feedback on your colleagues' work.

# **Required Texts/Readings**

There are no assigned readings for this class. However, students are required to incorporate at least 35 scholarly sources (peer-reviewed journal articles and academic books) into their applied project. Textbooks are not considered scholarly material. Students may use the scholarly sources they used in previous classes as long as they are directly applicable to the topic under investigation. Students may incorporate non-scholarly sources in their applied project but they do not count towards the scholarly sources required.

# **Course Requirements and Assignments**

Success in this course is based on the expectation that students will spend, for each unit of credit, a minimum of 45 hours over the length of the course for instruction, preparation/studying, or course related activities, including but not limited to internships, labs, and clinical practica. Other course structures will have equivalent workload expectations as described in the syllabus.

Introductory Discussion: Being that this is one of the final classes in the program, the introductory discussion requires each student to introduce themselves and provide the following information: (1) your name, (2) an enjoyable part of your holiday season, and (3) what you plan to do upon the completion of your MS degree. This assignment is due on Canvas on 1/26 by 11:59 pm.

Annotated Bibliography: For this assignment, students will select a topic they are interested in researching for their applied project, obtain 10 peer-reviewed journal articles published in the last 8 years on this topic, and complete an annotated bibliography. Additional information is available on Canvas.

This assignment is due on Canvas on 02/01 by 11:59 pm.

Description of Project—Discussion: In this assignment, students are required to provide a brief outline of the topic for their applied project. Additional information is available on Canvas.

This assignment is due on Canvas on 2/06 by 11:59 pm.

Applied Project Proposal: This proposal serves as the first half of your applied project. The proposal must be in paragraph format and structured with required headings and subheadings. Additional information is available on Canvas.

This assignment is due on Canvas on 2/12 by 11:59 pm.

Findings and Analysis: In this assignment, students will present the results and discussion for their applied project. Additional information is available on Canvas. This assignment is due on Canvas on 2/26 by 11:59 pm. Peer Review: Students will conduct a peer review of two of their classmates' applied projects. Students will be provided with specific questions to answer, and instructions for switching papers at a later date.

This assignment is due on Canvas on 2/28 by 11:59 pm.

Applied Project—Final Paper: For the final paper, students are required to combine all the components of the applied project and submit the final, polished version of their project. Additional information is available on Canvas.

This assignment is due on Canvas on 3/17 by 11:59 pm.

Applied Project Presentation: Students are required to present the research they conducted for their applied project to the class via PowerPoint. PowerPoint presentations should be recorded, last between 8 to 10 minutes, and be posted on Canvas. Additional information is available on Canvas.

This assignment is due on Canvas on 3/12 by 11:59 pm. Three posts on classmates' applied project presentations due on Canvas on 3/14 by 11:59 pm.

Poster Presentation (Optional): Students are invited to conduct a poster presentation of their applied project at the Graduate Student Showcase. This event will be held at the end of the spring semester and will be opportunity for students to share the findings of their research project in a classroom setting in the Department of Justice Studies. Additional details on location and time of the event will be provided at a later date. # Final Examination or Evaluation

The culminating activity for this class will be submission of the completed applied project (final paper) and the applied project presentation.

#### **Grading Information**

This is a credit/no-credit (CR/NC) course. In order to receive credit, students must complete ALL assignments/requirements associated with the applied project, including peer-reviews. Late assignments will not be accepted. If all requirements are not met, students will receive NC—unless they make prior arrangements with the professor to finish with an incomplete (I) and sign a "Contract of Incomplete." The professor may refuse to assign an incomplete (I).
