The STEM-NET Steering Committee is seeking CSU faculty nominations for the 2022-23 Faculty Fellow's program. Please forward the attached application to your nominated faculty.

Please note: In order for your nominated faculty members to apply for this program the faculty should be a Full-time tenured or tenure-track faculty with a disciplinary association with science, technology, engineering, or math (STEM) and who are active disciplinary and/or pedagogical scholars.


The period of appointment will be from **summer 2022 through spring 2023**.

Compensation is a **summer 2022** stipend of \$5,000 and three (3) semester units (AWTU) for each semester, **fall 2023** and **spring 2023**. Of these funds, **STEM-NET will contribute one (1) unit (AWTU) (\$2,018/unit) for each semester and \$2,500 summer stipend. The institution is to contribute two (2) units (AWTU) (\$2,018/unit) per term and \$2,500 stipend.**

**There is a limit of one Faculty Fellow application per institution. The deadline for electronic submission of applications to the STEM-NET office is 5:00 pm on Monday, March 11, 2022.**

## Call for Nominations to serve as a STEM-NET Faculty Fellow

Deadline: **5:00 pm on Friday, March 11, 2022.**

Full-time tenured or tenure-track faculty with a disciplinary association with science, technology, engineering, or math (STEM) and who are active disciplinary and/or pedagogical scholars are invited to apply for the newly created STEM-NET Faculty Fellows program.

The CSU currently has ten multi-campus collaborations, also known as affinity groups, which conduct collaborative activities in research and education on a breadth of topics. The latest group to be recently established is STEM-NET, and it may potentially constitute the most extensive of affinity groups since all 23 campuses are members. The expectation is that STEM-NET will eventually be self-funded through grants and contracts.

The STEM-NET vision is to make the CSU a worldwide leader in increasing the pipeline, preparation, graduation, and employment of outstanding, diverse STEM students. The mission is to enable CSU STEM leaders to share expertise and leverage system-wide opportunities to foster the implementation of global best practices in research, pedagogy, and learning as related to the STEM fields within the CSU.

This call to serve as a faculty fellow to further develop the role of the university with STEM-NET is also serving to test the benefits of STEM-NET faculty fellows at campuses across the CSU. In subsequent years, the nature and amounts of available funding will depend on the direction taken by the Executive Director, in conjunction with the Steering Committee.

**Period of appointment:** **summer 2022 through spring 2023.**

**Compensation** is a **summer 2022** stipend of \$5,000 and three (3) semester units (AWTU) for each semester, **fall 2022 and spring 2023.**

**Reporting:** The faculty fellow will report to the Provost (or designee).

Responsibilities:

1. Work with key faculty to develop and submit targeted STEM-based proposals, the subject areas of which are to be determined in consultation with the Provost (or designee).
2. Develop collaborative grants (educational- and research-based) with faculty.
3. Help promote a culture of scholarship on campus.
4. Take on new initiatives designated by the Provost.

Continuation of appointment beyond initial period of appointment is contingent upon budget, organizational needs, and performance.

**Application Materials:** Please provide a brief cover letter (4 pages maximum) that summarizes your background and your interest for this position. Include a detailed resume, and the contact information for three references in addition to your department chair.
