The SJSU Research Foundation Funding Alert System uses a database that matches faculty interests with external funding opportunities collected from various sponsoring agencies, and then sends email notifications to faculty subscribers based on the keywords they provide. NSF COLLABORATIONS CHANGING THE "PACE AND LOOK OF DISCOVERIES" VITAL TO OUR FUTURE

In a recent message to the research community NSF Director, Dr. France A. Cordova, talks about NSF's fortunate new partnerships and the agency's long history of working with private sector organizations, government agencies, and philanthropic institutions to leverage federal resources to advance science and engineering (S&E) research, education and training. The most recent partnership between NSF and the Boeing Corporation was announced in September will invest \$10 million to design and deploy online curricula to accelerate training in critical skill areas such as robotics, data science and artificial intelligence. To complement Boeing's contribution, Director Cordova states that "NSF's Directorate for Education and Human Resources will invest \$10 million for research focused on re-skilling and improving the technical abilities of the nation's S&E workforce. Boeing will also contribute \$1 million to NSF INCLUDES, an initiative to broaden S&E participation and one of the agency's **10 Big Ideas**." The funding is intended to help support programs that focus on the needs of women returning to the science and engineering workforce, especially veterans.

The Grant resource Center (GRC) Funding Summit will be held February 19-22, 2019 at [the Madison Washington, D.C.](#) Registration is now open. This event will provide a unique opportunity for attendees to get the latest information on funding programs, gain application tips and insights, network with colleagues and meet privately with grant officers.

Sessions already confirmed focus on the Institute of Museum and Library Services, National Endowment for the Arts, National Endowment for the Humanities and federal updates from AASCU's government relations division. Additional sessions in progress focus on the National Institutes of Health, National Science Foundation, U.S. Department of Education and more! Finally, the Honorable Henry Bonilla, former congressman from Texas, will give the keynote address.

OMB OUTLINES EFFORTS TO STREAMLINE THE FEDERAL GRANTS PROCESS

In a memo issued in early September, Office of Management and Budget (OMB) Director, Mick Mulvaney outlined strategies to streamline the federal grants process. All federal agencies have been given guidelines requiring them to report on plans to implement new federal data standards for grant awarding systems by April 30, 2019. The dual focus of this new effort is (1) to reduce the compliance burden and (2) to simplify the reporting process.

Agencies are being required to take actions to reduce the number of systems through which grants are processed. Effective January 1, 2019, form SF-424B will become optional and agencies are to plan to phase out use in Funding Opportunity Announcements. The memo further states that "effective January 1, 2020, the System for Award Management (SAM) will become the central repository for common government-wide certifications and representations required of Federal grants recipients." USAID DEVELOPMENT INNOVATION VENTURES PROGRAM ACCEPTING APPLICATIONS

The U. S. Agency for International Development (USAID) has announced a new round of available grants under its Development Innovation Ventures (DIV) program. The DIV program supports the testing and scaling of innovation to tackle global development problems. While USAID will consider applications on any project designed to confront these problems, projects will be judged primarily on three criteria: rigorous evidence of impact, cost-effectiveness, and a viable pathway to scale and sustainability.

Grants are made for projects in three stages: Stage 1: Proof of Concept, with grants of up to \$200,000 over three years. Stage 2: Testing and Positioning for Scale, with grants of \$200,000 to \$1.5 million over three years. And Stage 3: Transitioning Proven Solutions to Scale, \$1.5 million to \$5 million over five years. USAID anticipates 25-35 awards between all three stages. Applicants may apply for any stage. Applications are currently being accepted on a rolling basis.
