13 Legislative History: The charge and membership information for the Academic  
14 Disqualification and Reinstatement Review Committee (ADRRRC) resides in S19-2  
15 (which modified SM-F09-2). This proposal would rescind that Senate Management  
16 resolution and update the committee's membership with a new Senate Management  
17 Resolution.

19 Whereas: An update to the charge and membership of committees has recently  
20 been approved (S19-2), and

21  
22 Whereas: The ADRRRC has requested changes consistent with organizational  
23 restructuring that created a college of graduate studies, therefore be it

24  
25 Resolved: That SM-F09-2 be rescinded and that the charge and membership for the  
26 ADDRC would be as follows.

28 Charge: Enforces and reviews academic regulations governing disqualification and  
29 reinstatement to the University. Serves as the review committee for students whose  
30 petitions have been denied for Change of Major/Adding a second major/or minor for  
31 students with more than 90 units, per PD 2009-05.
