ACADEMIC COUNCIL POLICY RECOMMENDATION #F70-11

At its meeting of November 23, 1970, the Academic Council approved the following amendments to the Statement on Student Rights and Responsibilities, #S68-27, proposed by Chairman Marshall Maddock of the Student Affairs Committee. These amendments are necessary to bring the document into conformity with recent policies adopted by the Board of Trustees regarding student actions for which sanctions may be imposed and recently enacted disciplinary procedures.

The amendments were approved as follows:

VIII. SUMMARY OF STUDENT ACTIONS FOR WHICH SANCTIONS MAY BE IMPOSED

- C. (First two sentences, no change. Re-number the following as indicated. Place the following paragraph--formerly VIII, F. 10--below the new item 6.)
1. Formal written reprimand;
  2. Restriction of privileges granted by the college and the Associated Student Body;
  3. Disciplinary probation;
  4. Suspension from the college;
  5. Expulsion from the college;
  6. Financial restitution to the college or any member of the college community.
- a. Whether or not the loss or damage was willful, students may be required to make restitution for loss of or damage to any college property including that loaned or entrusted to them or for any failure to account for such property. Restitution may also be required for any loss of, damage to, or failure to account for property of a student organization. The College may withhold grades, transcripts, registration privileges and diplomas from any student who has failed to make appropriate restitution for loss to, damage of, or failure to account for college or student organization property when required to do so.

(Delete current Section F and replace it with the statement indicated below.)

- F. Students may be subject to sanctions upon proof that they have violated either the "Board of Trustees Policy Relating to Conduct on State College Campuses", November, 1968, or Sections 41301 or 41302 in Article 1, Chapter 5, Title 5, of the California Administrative Code. See Attachment A.

(Add a new Section G to read as indicated.)

- G. In addition to Trustee policy and Title 5 students may be subject to sanctions upon proof that they have engaged in the following:
1. Using or committing any fraud or dishonest practice in any official campus election.

IX PROCEDURAL STANDARDS FOR IMPOSITION OF SANCTIONS

- D. The following procedures shall be followed by the Student Judiciary Bodies.

(Section E titled "Student Judiciary Bodies" revise as indicated.)

- E. Procedures and standards followed by the Student Judiciary Bodies must conform to AS and College regulations. The authority of the AS Judiciary shall be limited to alleged violations of AS rules and regulations and questions arising under the AS Constitution and actions taken at the request of the College President in accordance with the provisions of paragraph 11a in Executive Order 116.

- G. Hearing Procedures for Violations of Trustees Policy and/or Title V Relating to Student Conduct

The College is required to employ "Student Disciplinary Procedures for the California State Colleges, Executive Order 116". See Attachment B.
