At its meeting of April 21, 2003, the Academic Senate passed the following Sense of the Senate Resolution presented by Bethany Shifflett for the Executive Committee.

**SENSE OF THE SENATE RESOLUTION  
WASC REVIEW STEERING COMMITTEE**

- Whereas, SJSU's accreditation review by the Western Association of Schools and Colleges is scheduled to take place over the time span ranging from 2003 - 2006, and
- Whereas, The development of an initial proposal to WASC framing the review process was facilitated by a proposal steering committee, and
- Whereas, Succeeding phases of the review process (as outlined in AVP Cooper's fall presentation to the senate) will require ongoing planning and facilitation by a steering committee, and
- Whereas, The breadth and depth of the planned review will need the active participation of as many individuals from the SJSU community as possible, therefore be it
- Resolved, That the SJSU Academic Senate endorse the establishment of a WASC Review Steering Committee charged with facilitating SJSU's accreditation review in accordance with the guidelines provided by WASC, and be it further
