 - a. Program has moved college homes over the last few years. Got merged with Geography and most recently to Environmental Studies. It is important that they find a home in order to find sustainability for themselves.
 - b. Data elements are weak.
 - c. Discovery majors= initial declaration is considered their discovery major.
 - d. They utilize faculty from other departments to run their courses.
 - e. Programs that are considered very weak will be asked to provide a sustainability plan. This program has never been reviewed so they should be given the opportunity to figure out how to sustain themselves before we recommend program termination.
 - f. Define what program is, possibly collaborate with Global Innovation and Leadership. Look at areas of specialization as opposed to concentrations.
 - g. Concern over program sustainability when they use outside courses. How does this support student major advising?

3. Geography

- a. Low faculty morale and tension in department, do not have fiscal sustainability, low student numbers
- b. External reviewer suggests redesigning program, hire new faculty and should look at ways to sustain program instead of closing.
- c. Has faculty who don't pull their workload, and it has been impeding the success of the program. Faculty have to be held accountable and recommendations should call out the inability to work together is going to impede the sustainability of the program.
- d. Termination should not be recommended but should be a repercussion should they not provide a sustainability report within a specific time frame of how they will address the issues with faculty morale and enrollment rates.
- e. Summary will be rewritten and a vote will be conducted online.

1. Technology

- a. When discussing the discontinuation of masters program we should highlight the reasoning being that there is no faculty to staff program and hasn't accepted students for a quite some time.
- b. Their GE Course TECH 98 has not been offered in more than five years and is on the GUP list of courses to be inactivated for Fall 2017.
- c. The BS program seems to have students shuffling around within their major, but there is no evidence about what is happening
- d. No research or creative activities were reported, so there was no way to determine how or if they are conducting RSCA.
- e. Department is considering separating programs. However, they are both small so is it an effective solution.
- f. Learning outcomes for the programs are completely different due to disciplines being different.

2. Aviation

- a. Resource issues currently which will increase as industry demand increases.
- b. Struggle to hire faculty and technicians.
- c. External reviewer believes this industry is growing and demand for this type of program is going to be high.
- d. Assessment seems to be low, they need to increase assessment activities.
- e. Struggle to hire PhD faculty due to area. They even struggle to hire masters level faculty. External reviewer suggested adjusting job descriptions
- f. Cost to obtaining a pilot's license is high and not covered by financial aid. So pilot training is a deterrent for students to come to SJSU.
- g. There were some concerns about rigor, but there was no way to determine rigor intensity and whether or not that is really an issue.
- h. The programs (aviation and tech) are seen as the stepchildren, by not receiving as many resources and college support as they should.
