Unfinished Business Items for 2015/2016

The Academic Integrity Policy gives instructors the right to assign an academic sanction independent of an administrative sanction from the Office of Student Conduct (OSCED). However, if the Student Conduct investigation concludes that the student is not responsible or dismisses the referral due to insufficient evidence, there is no process for the student to challenge the grade.

The SFC policy specifically states that grades that result from cheating are not issues of fairness and they should, therefore, be removed from the Student Fairness process, but fails to address how such grade disputes should be handled. Additionally, students have experienced difficulty in challenging an academic sanction when it is not reported to the OSCED or is reported, but is designated "No Action" by the referring faculty.

The issue was first referred to and discussed by ISA on 9/9/13 and it was tabled. The request to reconsider the issue was made to ISA on 4/4/14 at the suggestion of campus counsel. The issue was taken up by ISA again in Spring 2015, but was tabled for further discussion which did not occur before the semester ended. The issue will be raised with ISA again in Fall 2015.

Policy Concerns Identified in 2014/2015

The most common policy issues involved in the petitions received by the committee are consistent with previous years and the number of formal complaints has increased. In an effort to reduce course complaints, the SFC has compiled the attached list of *Strategies to Reduce Course-Related Complaints* for distribution to all faculty and request that it is done before the start of the Fall 2015 semester.

- Professer yelled at and was very rude to Melissa when discussing her performance in the class.

Discussion

- Professor acknowledged allowing other students to make up an assignment.
- In class assignments can be completed at home.
- Melissa was not frequently absent.

- Not much to add to his statement
- After the machete (which was Darby's) incident, he was not approached by any housing staff
- Darby was not told that he was being reported for the machete
- Gustav says he did not make any intentional threats
- He did not feel he did anything wrong
- Gustav maintains that he and Darby never had a conversation about "plotting against the snitch"

Student Conduct Director - Shannon Quihuiz

- In regards to the "assumption" of "plotting" in the letter to Darby in the incident description: it is based on information received by the office, but those claims were not substantiated. Specifically, code violation 7 (threatening behavior) was not substantiated.
- Darby and Gustav's conversation was misheard, they were not discussing plotting against anyone
- Gustav's cease and desist was not in regards to Darby's machete, rather it was about perceived threats ("plotting")
- The delay from SCED was due to backlog and miscommunication about cases that should be expedited
- SCED does not typically conduct mediation
- Darby did not have to go through the full conduct process for the machete as it was resolved quickly and he signed his settlement agreement

Housing Staff—Natina Gurley and Stephanie Hubbard

Darby and Gustav seemed to be unaware of the magnitude and that a formal process was

going to take place

- They did not want to seem bias since the issue involved a student staff member, which is why they just forwarded the case to SCED. It was also because the case involved a perceived threat
- Because housing was so full, they had little options for where to move Gustav and Darby
- A meal plan was provided
- There are not specific levels of reports, all incident reports are reviewed to determine the violation
- The UHS license agreement allows for administrative room changes with a 24 hour notice
- Students are not always notified when they are reported (usually involving Title IX issues or similar), this is to prevent possible retaliation and protect the person who submitted the report
- There was no report of a direct threat from Darby/Gustav

Discussion

- Issue with not intervening simply due to possibility of "perceived bias"
- There is a lack of informal problem solving in UHS
- Almost all departments have an informal resolution process
- Training (mostly for faculty) is undergoing about the difference between disruptive and threatening behavior. Staff should be upheld to be responsible for these differentiations as well
- Why was there an RA rooming with students?
- There needs to be mediation in cases like these that involve staff members

Recommendation: partial reimbursement for Gustav and Darby; additional training for RAs and a review of UHS policies in terms of informal resolutions and threat assessment.
