SFC Business Completed 2008/2009

The Student Fairness Committee (SFC) met 13 times during the 2008/2009 academic year (AY); 6 meetings in the fall semester and 7 meetings in the spring semester. The agendas and minutes summarizing the case dispositions are included with this report.

The number of students seeking assistance from the University Ombudsman during AY 2008/2009 was 370. The SFC investigated 10 cases, a significant compared to the three previous years. This increase may be due, in part, to an article in the Spartan Daily on December 10, 2008, which detailed the grievance/grade dispute process.
