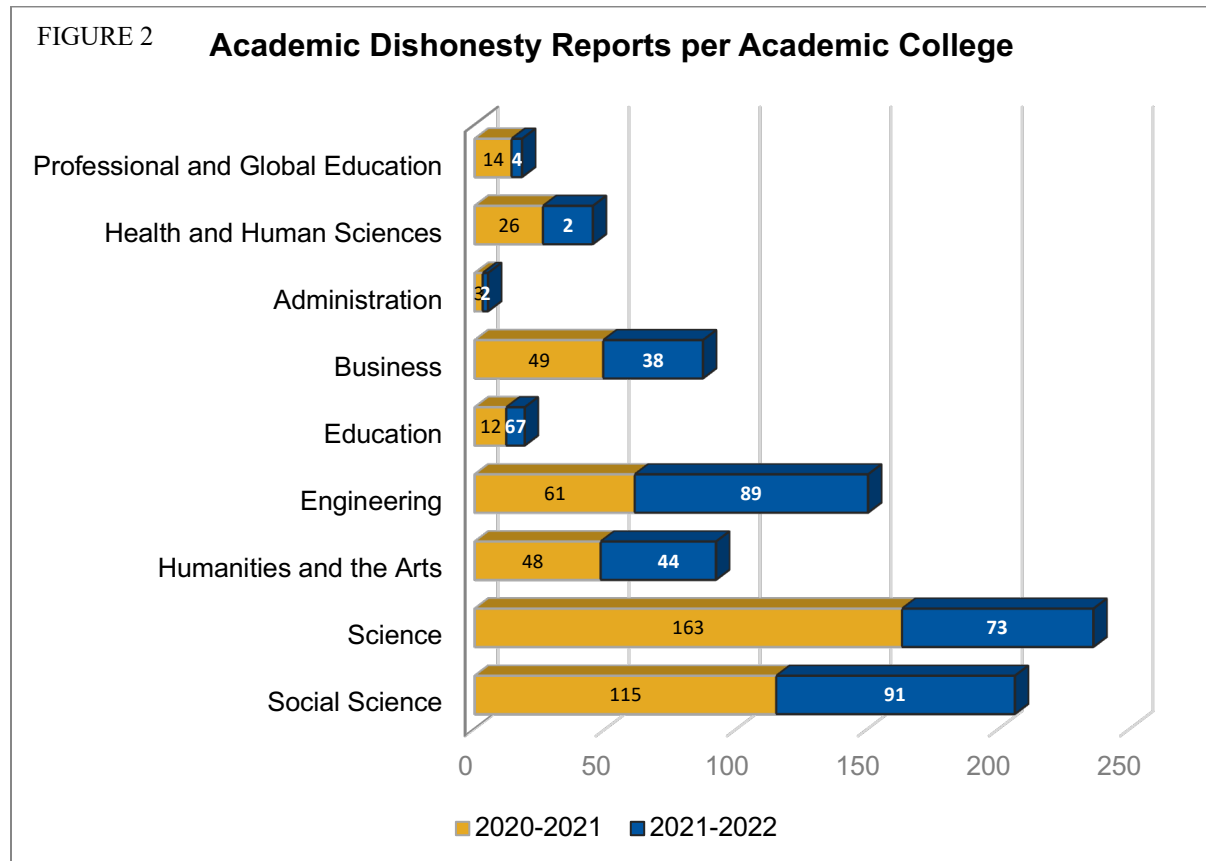
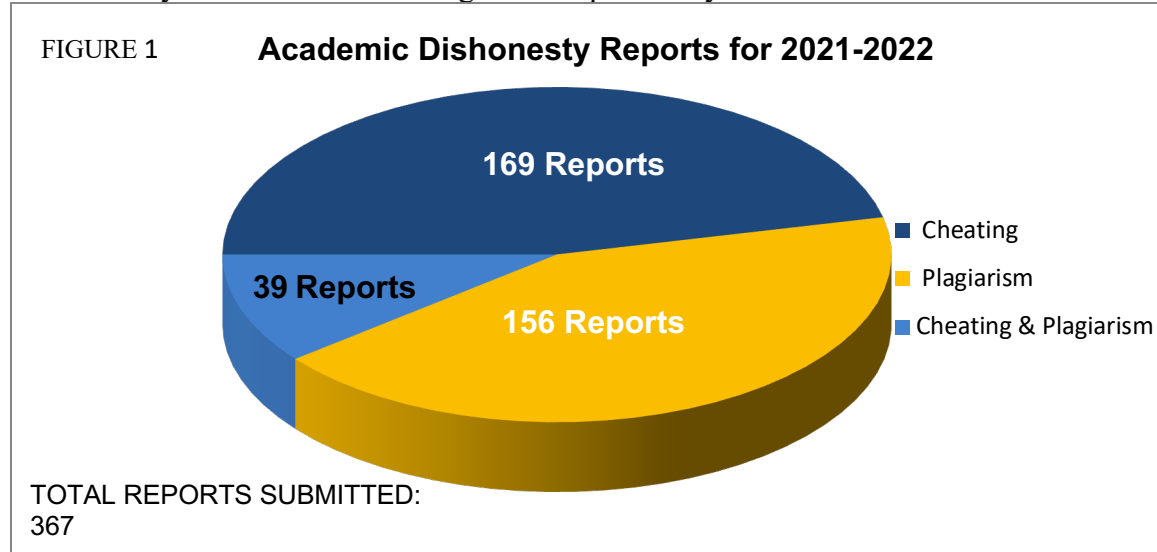


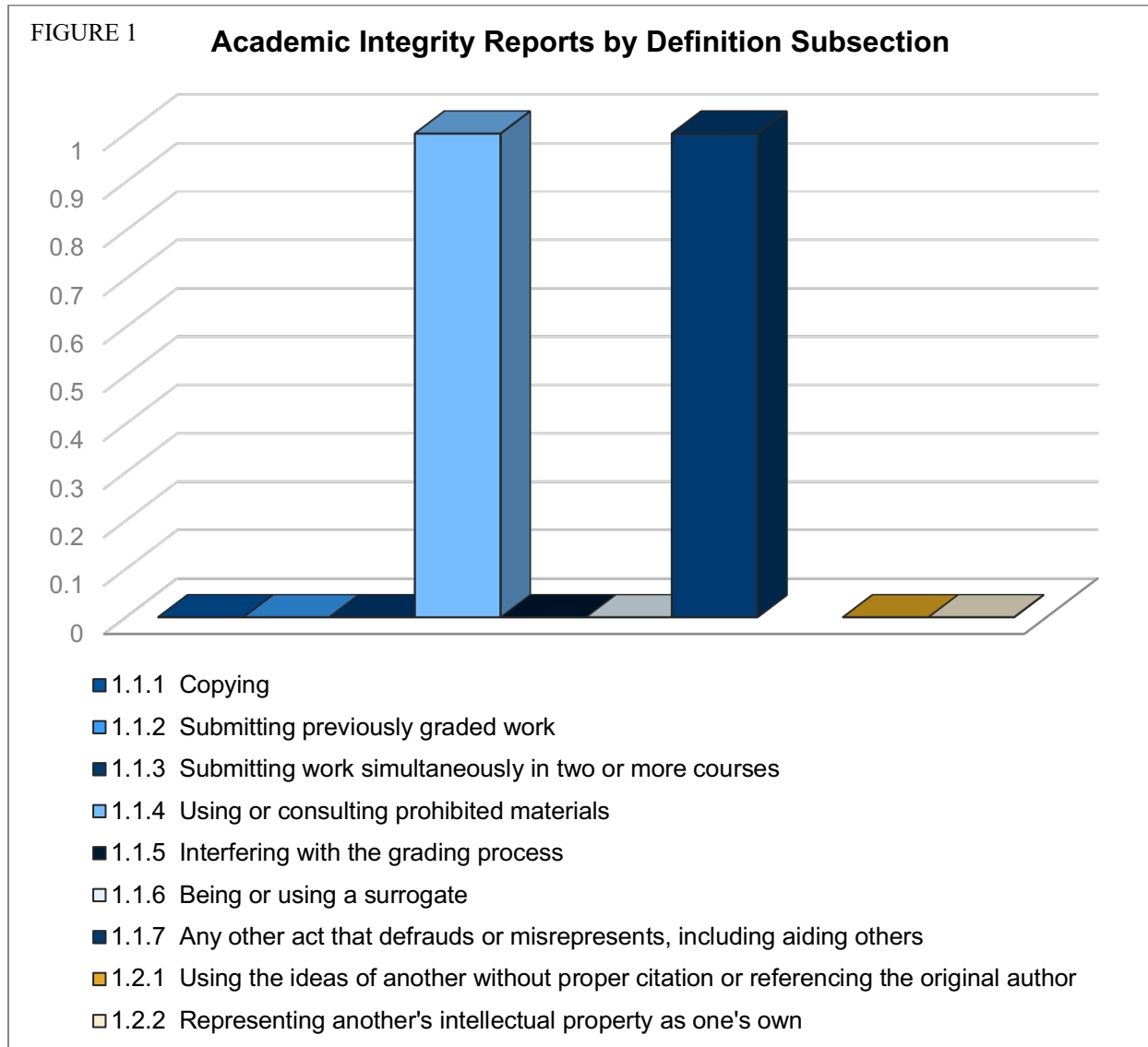
**F15-7 ACADEMIC INTEGRITY POLICY

Student Conduct and Ethical Development received **367 Reports** regarding violations of the Academic Integrity Policy for the 2021-2022 academic year. 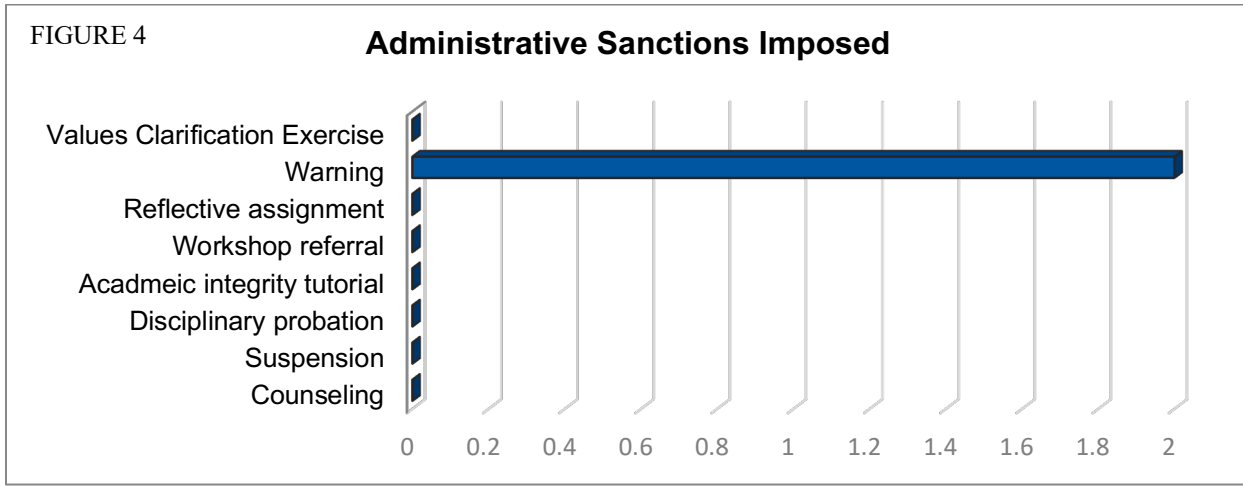
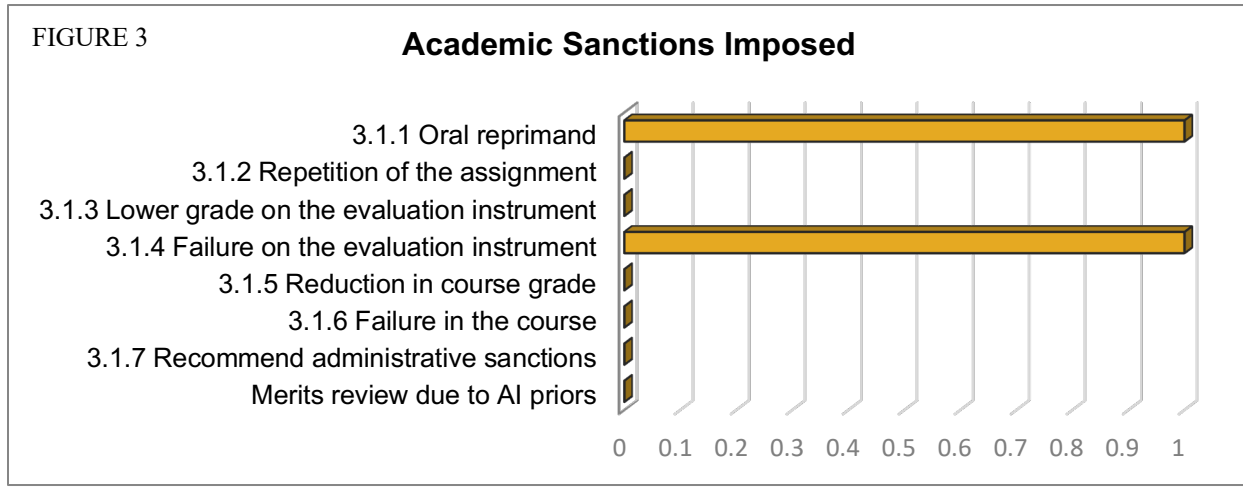
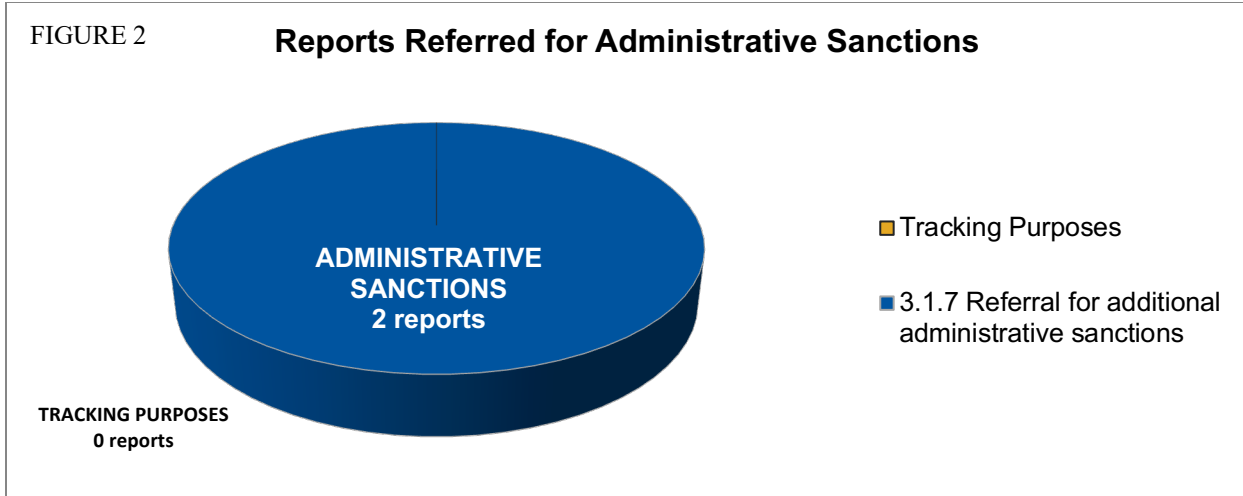


ADMINISTRATION

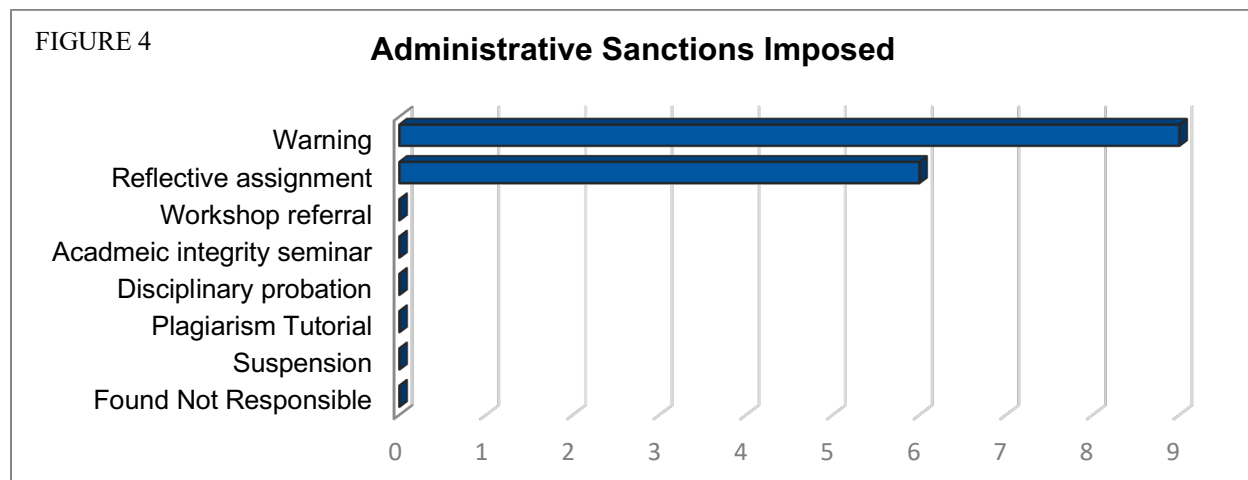
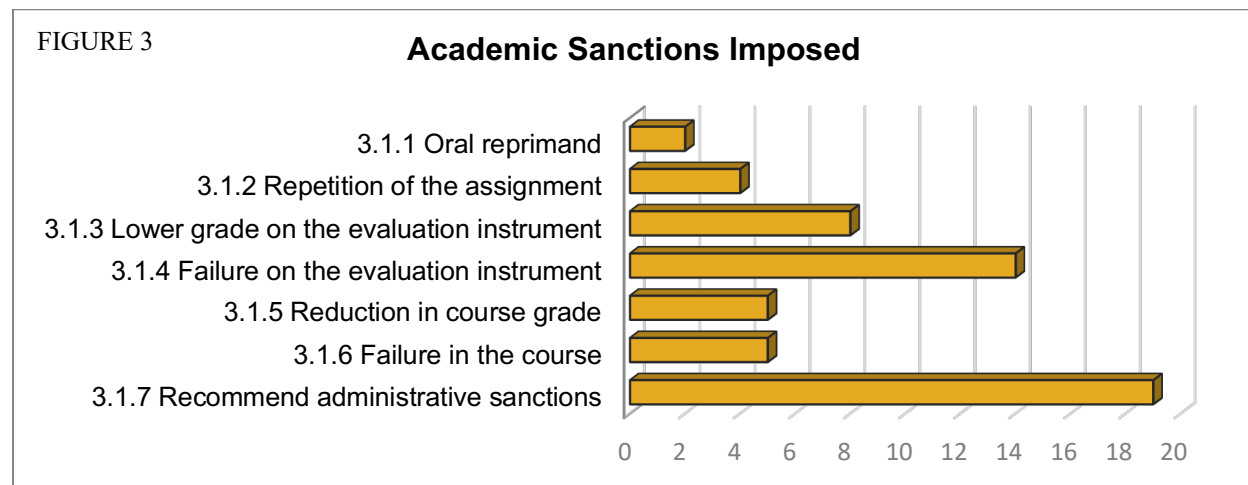
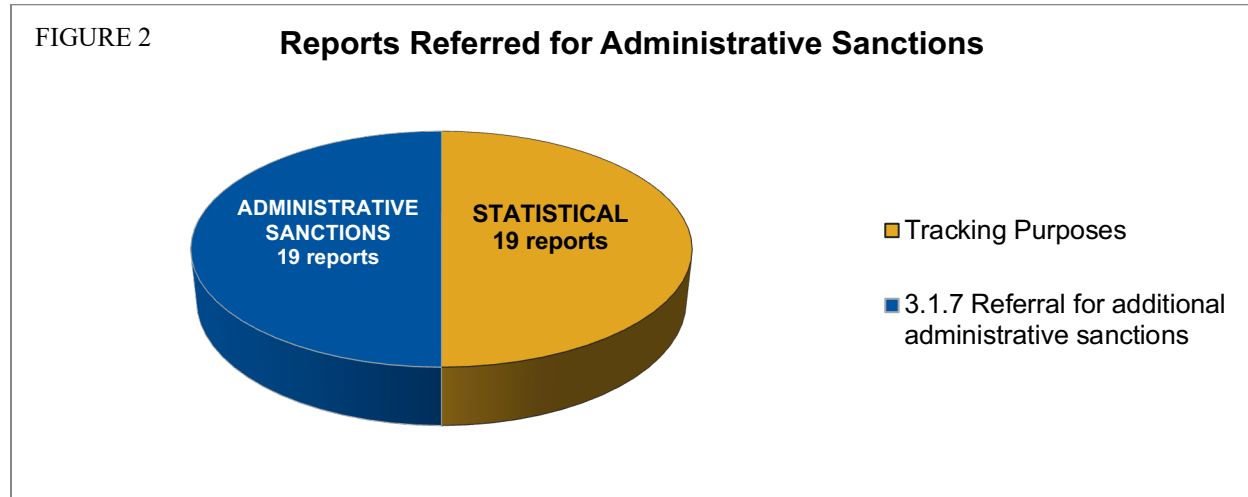
Faculty imposes academic sanctions and determines which cases are reviewed for violations of the Student Conduct Code (i.e., 3.1.7 Recommendation of additional administrative sanctions). Student Conduct and Ethical Development will initiate the student conduct process beyond the faculty designation in limited circumstances (i.e., when a student has prior violations of the Academic Integrity Policy). 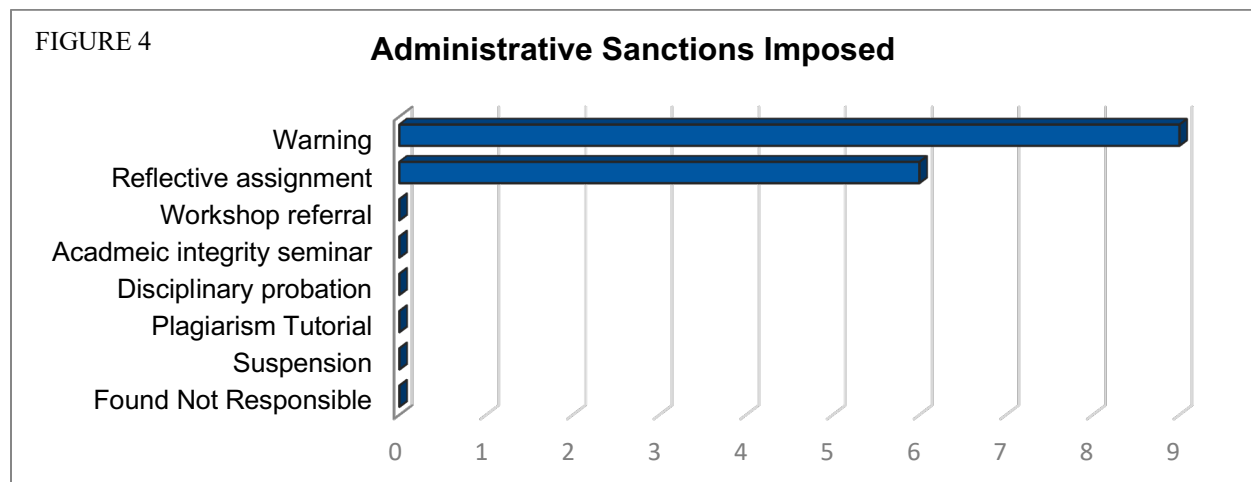
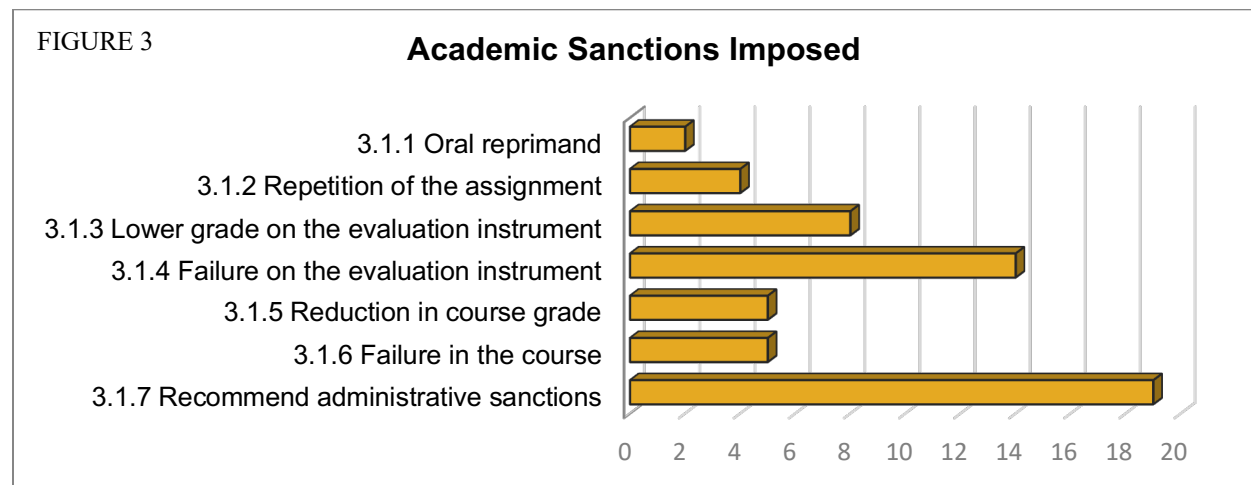
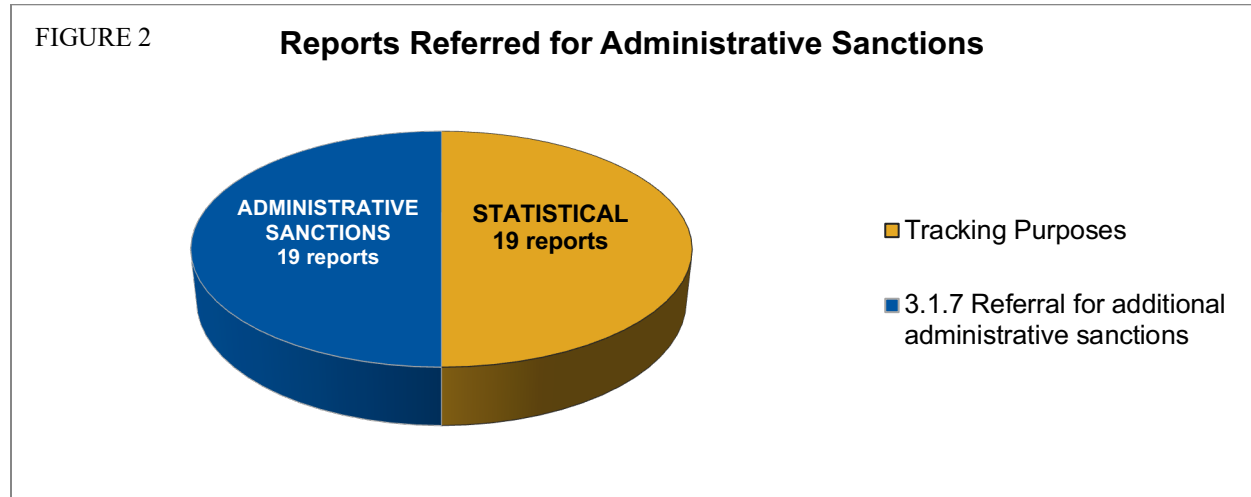
