- 1) Maintain “Good standing” during full-time enrollment in the MSW Program, complete all aspects of the MSW curriculum, and successfully graduate as a Title IV-E student.
- 2) Successfully complete and receive a grade of CREDIT in two years of field internship placement. One year of placement will take place in a public child welfare agency.
- 3) Maintain automobile insurance while enrolled in internship in the MSW Program.
- 4) Complete required Specialized Child Welfare Curriculum, including child welfare trainings and seminars.
- 5) Obligation to pay back this award is on a year-to-year basis. For example, a full-time student has a two-year employment commitment in a public child welfare agency; if a part-time employee, there is a three to four year employment commitment in a public child welfare agency.
