Immigrant Legal Defense (ILD) Higher Education Immigration Services CSU Immigration Services Project Summary of Data: San José State University



July 2019 - August 2023 Data for ILD's 9 CSU Campuses

In the four years of ILD's legal educational partnership with our 9 CSU campuses,¹ ILD attorneys provided 5,052 individual one-on-one consultations to 3,055 students, 164 faculty/staff, 1,505 family members, and 328 alumni. In addition, ILD has opened 3,750 cases for immigration legal services representation. ILD has served clients from 99 countries,² who reside in 43 California counties. Our clients ranged in age from infant to 95, with the vast majority being over age 17 and under 50.

In addition to our direct legal services over the past four years, ILD conducted 163 presentations reaching 5,900 individuals, including in-person and Zoom presentations, CSU system-wide webinars, trainings for staff and faculty, discussions with student groups, and information sessions for student government leaders. Additionally, ILD attorneys participated in dozens of meetings with campus student-leaders and faculty/staff for in-depth discussions on requested immigration law and policy topics, along with several social media live stories.

ILD also authors a blog on current relevant immigration law and policy topics for our CSU campuses. As well as co-host a podcast with the Fresno State Dream Success Center that focuses on immigration law and policy topics raised by students on the campuses we are serving and feature guest speakers from the national immigration law and policy field. August 2022 - August 2023 Data for ILD's 9 CSU Campuses

Over the past year, ILD accepted 1,245 cases for full-scope representation. In addition, ILD continued representation of 668 existing CSU clients from cases opened prior to August 2022. Our CSU campus affiliated cases include the following forms of relief:

- DACA renewal
- DACA Advance Parole
- Removal Defense for individuals in immigration deportation proceedings
- Asylum for those seeking protection due to race/ethnicity, religion, nationality, political opinion, or membership in a particular social group
- U visa for victims of serious crimes who have cooperated with law enforcement
- T visa for victims of human trafficking
- VAWA for victims of domestic violence
- Special Immigrant Juvenile Status (SIJS) for individuals under 21 who have been abused, abandoned, or neglected by one or both parents
- Naturalization petitions for U.S. citizenship
- Family Petitions for lawful permanent residency based on a relationship to a spouse, child, parent, or sibling
- Adjustment of Status petitions for lawful permanent residency based on various grounds
- Parole in Place Adjustment of Status petitions to allow for lawful permanent residency for family members of U.S. military members and veterans
- Waivers of Inadmissibility (pardon) to allow for a petition for lawful permanent residency

Between August 2022 and August 2023, ILD provided 1,551 individual one-on-one consultations to 783 students, 49 faculty/staff, 481 family members, and 238 alumni. ILD also reached 1,042 individuals with our presentations and trainings to the CSU community.

SJSU SAN JOSÉ STATE UNIVERSITY

In the past four years at San José State, ILD has conducted 806 individual one-on-one consultations to 525 students, 17 faculty/staff, 220 family members, and 44 alumni. ILD has also provided legal representation to San Jose State affiliated clients in 251 DACA cases, 34 DACA advance parole cases, 110 background checks, 41 adjustment of status to lawful permanent residency cases, 18 family petitions, 16 naturalization and U.S. citizenship cases, 14 SIJS cases, 10 U visa/VAWA cases, 5 asylum cases, as well as various other immigration cases. Since 2019, ILD has served clients at San José State from 55 countries³primarily between the ages of 18-30.

August 2022 - August 2023 Data for San José State

At San José State from August 1, 2022 through August 31, 2023, ILD attorneys conducted 295 one-on-one consultations with 162 students, 11 faculty/staff, 85 family members, and 37 alumni. We accepted 238 new cases for representation, including 87 DACA cases, 19 DACA advance parole cases, 64 background check cases, 26 adjustment of status cases, as well as representation in 49 various other immigration cases.

Additionally, the San José State community also attended regular ILD webinars over the year. ILD and San José State have collaborated on social media posts to bring awareness to immigration issues as well as promote the resources on campus, including ILD's CSU legal services.
