## ANNUAL EVALUATIONS OF TEMPORARY FACULTY FOR 2019

TO: Campus Academic Leaders

This memorandum provides information and materials for the annual review of full-time and part-time temporary Unit 3 faculty members ("temporary faculty"), for calendar year 2019. Each college or equivalent unit should provide these materials to temporary faculty **by September 3, 2019**, in accordance with Article 12.2 of the CSU/CFA Collective Bargaining Agreement ("CBA") which states:

Each new faculty unit employee shall...be provided no later than fourteen (14) days after the start of the semester with written notification of the evaluation criteria and procedures in effect at the time of his/her initial appointment. In addition, pursuant to provision 15.3, the faculty unit employee shall be advised of any changes to those criteria and procedures prior to the commencement of the evaluation process.

UP - FA distributes evaluation materials in the fall semester. The annual review process for all temporary faculty is to completed by April 1.

No offer of appointments should be made before the completion of annual evaluations. An appointment will not be approved until the faculty member's annual evaluation has been received by UP-Faculty Affairs.
