Part-time Lecturer, Department of English and Comparative Literature

The Department of English and Comparative Literature at San José State University is seeking a candidate for the teaching of poetry writing at the graduate level in AY 2020-2021.

Qualifications:

Required:

- PhD or MFA in Creative Writing with significant publications in poetry.
- Minimum of three (3) years teaching college-level courses required, preferably to a multicultural / multilingual student population.
- Strong commitment to and evidence of excellence in teaching (e.g., professional development workshops, academic conferences, scholarly publications, teaching evaluations).
- Applicants must demonstrate an awareness of and sensitivity to the educational goals of a multicultural population as might have been gained in cross-cultural study, training, teaching and other comparable experience.

Brief Description of Duties:

- Teach one section of the graduate poetry writing workshops
- Support the writing development needs of a diverse student population through course materials, teaching strategies, writing support, and advisement.
- Provide data for program assessment and ongoing programmatic research, as needed.
- Candidate must demonstrate awareness and experience understanding the needs of a student population of great diversity – in age, cultural background, ethnicity, primary language and academic preparation – through inclusive course materials, teaching strategies and advisement.

- A letter of application that addresses qualifications and teaching philosophy
- Curriculum vitae
- Three (3) current letters of recommendation
- An official transcript from the institution of your highest level of education (if you have not been previously employed by SJSU)

Applications should be sent as one pdf file with the exceptions of transcripts and letters of recommendation may be sent under a separate cover. Applications will be accepted on a rolling basis.
