- Possess excellent communication and interpersonal skills.
- Demonstrate awareness of and sensitivity to educational goals of a multicultural population as might have been gained in cross-cultural study, training, teaching and other comparable experience.

### Responsibilities:

- Primary disciplinary needs are in the areas of financial accounting and accounting information systems. Teaching assignments are at both the graduate and undergraduate levels in traditional and accelerated formats
